







I am directed to intimate that all departments concerned with DBT schemes should ensure the implementation of face-based Biometric Aadhaar Authentication across all beneficiaries under all DBT schemes (including Centrally Sponsored Schemes) by 31st December, 2023. Also 100% payments in all CSS should only be made through the Aadhar Payment Bridge (ABP) and similar initiative may also be taken in respect of State DBT Schemes.

Please treat the matter as most urgent and follow the time line to complete this task. You are also requested to send the progress report to State DBT Cell on fortnightly basis.




