Subject: - To incur of expenditure under Capital / Revenue Schemes.

Kindly refer to Finance Department's earlier Memo of even No. dated 20 April, 2016 wherein all the Administrative Departments were allowed to incur expenditure under approved plan schemes upto 25% in 1st quarter, 20% in 2nd quarter, 25% in 3rd quarter and 30% in 4th quarter without any reference on this account to the Finance Department.

- 2. It has been observed by Principal Accountant General (A&E), Haryana that in the month of February / March, some Departments have incurred more expenditure as compared to other months in last quarter of the financial year under Capital / Revenue Schemes. This practice needs to be curbed.
- 3. For effective financial management and to avoid the rush of expenditure in last quarter of the financial year, Finance Department has decided to allow all the Administrative Departments to incur expenditure under Capital / Revenue Schemes only upto 25% in 1st quarter, 20% in 2nd quarter, 25% in 3rd quarter and 30% in 4th quarter. These ceiling should not be applicable on Salary-01, D.A-03, Wages-02, Medical Reimbursement-67, Contractual Services-69, Professional & Special Servcies-33 and Ex-gratia-79 object heads.
