

As per the DO letter, the Social Audit Unit, Haryana (HSSAAT) is conducting Social Audits of schemes under DoSJE in Districts Ambala, Sirsa, Sonapat and Hisar from 09/10/2023 onwards. The schemes which are undergoing for Social Audits are Senior citizen homes, Drug De-Addiction Centre IRCA, Residential School under SIRESHTA and PM-AJAY (Calendars attached). The expenditure of these Social Audits shall be borne by National Resource Centre for Social Audits (NRCSA) of MoSJE, Govt.

It is therefore, requested to kindly nominate a state nodal officer from School Education Department for coordination in conducting Social Audits of schemes related to Education Department and also in assisting Social Audit Unit (HSSAAT) for organizing Social Justice Assembly, also who can direct District and Tehsil level officials of 4 district namely Hisar, Sonapat, Ambala, Sirsa to coordinate with VRPs (Social Auditors). It is also informed that the Social Justice assembly has been scheduled on 15th December, 2023 in district Sonapat. The W/Joint Secretary, Ministry of Social Justice will be present in this assembly. Therefore, you are further requested to kindly nominate a nodal officer of your department, who will coordinate with district administration/officials at district headquarters.
