ORDER NO. 13/53-2023 PGT-II (5)

DATED, PANCHKULA 21.10.2023

Whereas, Sh. Upander Kumar & Others had filed CWP No. 5957 of 2023 titled as Upander Kumar & Others v/s State of Haryana and others before the Hon'ble Punjab & Haryana High Court praying therein to grant benefit of annual increment in pay for the purpose of retirement benefits, which become due on 1st July, as the same was not granted as petitioners were superannuated from their services on 30.06.2022 and all consequential benefit including the pensionary benefits as per Sixth Pay Commission.

Whereas, the aforesaid civil writ petition came up for adjudication before the Hon'ble High Court on 22.03.2023 and on that day, the same was dispose of with direction to respondents to decide the legal notice dated 12.12.2022 (P-4). The operative part of the order/direction dated 22.03.2023 is reproduced as under:

"...In view of the above, without expressing any opinion on the merits of the case, respondent No.2-Director, Secondary Education Haryana, is directed to decide the aforesaid legal notice dated 12.12.2022 (Annexure P-4) by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order".

Whereas, in compliance of the abovementioned order/ direction the legal notice dated 12.12.2022 (P-4) of the petitioner was examined at length, wherein it has been found that the petitioner No. 3 namely Narender pal is claiming for grant of annual increment along with all consequential benefits. After examination of the matter, it has been found that his claim is not maintainable as per Govt. of India instructions issued vide Memo No. 6/183/2018-4PR (FD) dated 25.11.2020. In Para No.12 of the same instructions dated 25.11.2020, it has been observed by the department that the claim of grant of annual increment of any Government employees/claimant who were not in service on



1st July due to retirement/superannuation is not tenable. The extract of Para No. 12 of the instruction dated 25.11.2020 is as under:-

“Keeping in view the aforesaid information provided by the GOI and the fact that the rules on the issue of grant of annual increment as applicable in the case of central Govt. employees are still intact and have not been quashed by any orders of the Hon’ble Courts in including orders passed by the Hon’ble Madras High Court in P. Ayyamperumal case, the GOI has not generalized the order passed in P. Ayyamperumal case of the Hon’ble Madras High Court. Thus, the Finance Department observes that the claim of annual increment to the Government employees/petitioners, who are not in service on 1st July due to retirement/superannuation, is not tenable.

Whereas, as per the Finance Department, Haryana instructions vide memo no. 6/183/2018-4PR (FD) dated 25.11.2020(*supra*), it is clarified that the claim of annual increment of Government employees/claimants who were not in service on 1st July due to retirement/superannuation is not tenable.

In view of the above circumstances, claim of the petitioner No. 3 namely Narender pal demanded through legal notice dated 12.12.2022 (P-4) is not tenable and the same is liable to be rejected being devoid of merit.

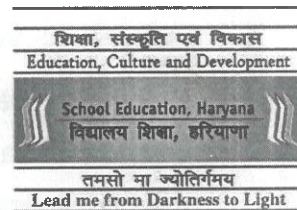
