Whereas, Smt. Jai Bharti had filed CWP No. 6615 of 2023 titled as Partap Sharma and others vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent-Department to promote the petitioners to the post of Post Graduate Teacher (PGT) English w.e.f. 08.01.2021, the date of promotion of the junior TGTs with all the consequential benefits.

The Hon'ble High Court was pleased to dispose of the said writ petition vide order dated 29.03.2023 with following orders:-

*“.....In view of the above, without expressing any opinion on the merits of the case, respondent No.2- Director of Elementary Education, Haryana, is directed to decide the representation dated 14.11.2022 (Annexure P-4) by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order, in accordance with law.*

**Disposed of.”**

In compliance of above said order, the representation dated 14.11.2022 of Smt. Jai Bharti, TGT English was perused and examined. After examination, it has been found that she was initially appointed as PRT/JBT on 20.12.2004 and later on, promoted to the post of TGT/Master (English) on 17.07.2020 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT English; or  
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.


Whereas, Smt. Jai Bharti joined as TGT English on 22.07.2020. The cutoff date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021. On that day, petitioner did not possess the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted



to the post of PGTs on 08.01.2021 reason being that they possessed the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Smt. Jai Bharti is not tenable & hereby rejected being devoid of merits.

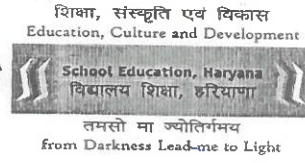
