Whereas, Sh. Ravinder Singh had filed CWP No. 16109 of 2023 titled as Ravinder Singh vs. State of Haryana & others praying therein to direct the respondent department to promote the petitioner to the post of PGT English w.e.f. 08.01.2021 the date of the junior TGT teachers who have been given promotion with all the consequential benefits.

The Hon'ble High Court was pleased to dispose of said writ petition vide order dated 01.08.2023 with following orders/direction:-

“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, dated 18.5.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”

In compliance of above said order, the representation dated 18.05.2023 of Sh. Ravinder Singh, TGT English was perused and examined. After examination, it has been found that he was initially appointed as PRT/JBT on 06.10.2000 and later on, promoted to the post of TGT/Master (English) on 17.07.2020 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion to the post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

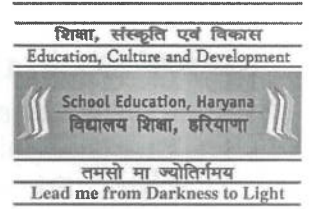
