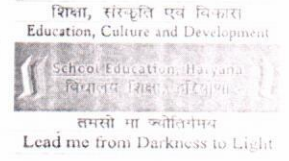

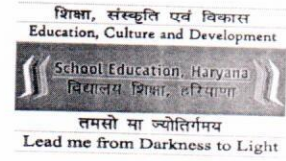

Whereas, Sh. Sonu Kumar had filed CWP No. 15864 of 2023 titled as Sonu Kumar vs. State of Haryana & others praying therein to direct the respondent Department to consider and promote the petitioner on the post of PGT-English, w.e.f. 8.1.2021, i.e., the date when his juniors were so promoted.

The Hon'ble High Court was pleased to dispose of the said writ petition vide order dated 01.08.2023 with following orders/direction:-

*“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, dated 30.1.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”*

In compliance of above said order, the representation dated 30.01.2023 of Sh. Sonu Kumar, TGT English was perused and examined. After examination, it has been found that he was initially appointed as PRT/JBT on 06.10.2000 and later on, promoted to the post of TGT/Master (English) on 17.07.2020 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion to the post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

(i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND

(ii) 2 years teaching experience as TGT English; or

Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Sh. Sonu Kumar joined as TGT English on 22.07.2020. The cutoff date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021. On that day, petitioner did not possess the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted






to the post of PGTs on 08.01.2021 reason being that they possessed the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Sonu Kumar is not tenable & the same is hereby rejected being devoid of merits.

Whereas, Sh. Raj Kumar had filed CWP No. 18217 of 2023 titled as Raj Kumar vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court prayed therein to direct the respondent-Department to promote the petitioner to the post of Post Graduate Teacher (PGT) Political Science w.e.f. 08.01.2021, i.e. the date of promotion of the junior, TGT teachers with all the consequential benefits.

The Hon'ble Punjab & Haryana High Court was pleased to dispose of the said writ petition vide order dated 21.08.2023 with following directions:-

*“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, Annexure P-4, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”*

In compliance of above said order, the representation dated 23.06.2023 of Sh. Raj Kumar, TGT Social Studies was perused and examined. After examination it has been found that he was initially appointed as PRT/JBT on 02.12.1997 and later on, promoted to the post of TGT/Master (Social Study) on 30.10.2010.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion to the post of Political Science PGT (Post Graduate Teacher) from Social Studies TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

- (i) M.A. Political Science with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT Social Study; or

Whereas, Sh. Raj Kumar joined as TGT Social Studies on 30.12.2010 and he acquired the qualification of M.A. Political Science on 20.04.2022. The cut-off date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021 and thereafter, again the promotion cases were invited and cut-off date for sending the cases for promotion through proper channel was 30.11.2021 and the

promotion orders were issued on 13.04.2022. On that day, petitioner did not possess requisite qualification (M.A. Political Science) as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, he was found ineligible for promotion to the post of PGT (Political Science). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 and 13.04.2022 reason being that they possessed the requisite experience and qualification for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Raj Kumar is not tenable & hereby rejected being devoid of merits.


