“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, dated 27.2.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.

In compliance of above said order, the representation dated 27.02.2023 of Sh. Dalip Kumar, TGT English was perused and examined. After examination, it has been found that he was initially appointed as PRT/JBT on 11.10.2000 and later on, promoted to the post of TGT/Master (English) on 17.07.2018 w.c.f. 17.07.2020.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion to the Post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

By promotion:-

(i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND

(ii) 2 years teaching experience as TGT English; or


Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Sh. Dalip Kumar joined as TGT English on 22.07.2020 and he acquired the qualification of M.A. on 23.03.2022. The cutoff date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021 and thereafter, again promotion cases were invited and cutoff date for applying for the promotion by

sending the cases through proper channel was 30.11.2021 and promotion order were issued on 13.04.2022. On that day, petitioner did not possess requisite qualification (M.A. English) as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 reason being that they possessed the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Dalip Kumar is not tenable & the same is hereby rejected being devoid of merits.

Ordered accordingly.

Mamta Rani had filed CWP No. 21507 of 2023 titled as Mamta Rani vs. State of Haryana & others praying therein to direct the respondent-Department to promote the petitioner to the post of Post Graduate Teacher (PGT) Social Studies w.e.f. 08.01.2021, the date of the junior TGT teachers who have been given promotion with all the consequential benefits.

The Hon'ble High Court was pleased to dispose of the said writ petition vide order dated 10.10.2023 with following orders/directions:-

“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, Annexure P-4, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”

In compliance of above said order, the representation dated 30.03.2023 of Smt. Mamta Rani, TGT Social Studies was perused and examined. After examination it has been found that she was initially appointed as PRT/JBT on 27.01.1999 and later on, promoted to the post of TGT/Master (Social Studies) on 05.12.2010.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of Economics PGT (Post Graduate Teacher) from Social Study TGT (Trained Graduate Teacher) is as under:-

By promotion:-

- (i) M.A. Economics/ Applied Economics /Business Economics with atleast 50% marks and B.Ed from recognized university; AND
- (ii) 2 years teaching experience as TGT Social Study

Whereas, Smt. Mamta Rani joined as TGT Social Studies on 26.04.2011 and she has acquired the qualification of M.A. Economics on 15.06.2022. The cut-off date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021 and thereafter, again promotion cases were invited and cut-off date for applying for the promotion by sending the cases through proper channel was 30.11.2021 and promotion orders were issued on 13.04.2022. On that day, petitioner did



not possess requisite qualification (M.A. Economics) as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (Economics) and also to the post of PGT (Social Studies). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 reason being that they possess the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Smt. Mamta Rani is not tenable & the same is hereby rejected being devoid of merits.
