Whereas, Daffodils Public School, Battu Road, Fatehabad was granted NOC for upto 10th level vide order no. 23/136-2000 V-1 (3) dated 29.03.2000 by the Director Secondary Education, Haryana, Panchkula.

Whereas Deputy Commissioner, Fatehabad received several complaints against Daffodils Public School, Battu Road, Fatehabad from Sh. Samsher Singh & Others alleging that the school management has changed the name of school without the approval of competent authority.

Whereas, Vide letter No. 6/64-2023 PS (4) dated 15.05.2023, the District Education Officer, Fatehabad was directed to enquire into this matter and submit a report. The District Education Officer, Fatehabad submitted her report vide letter no G-3-2023/1916 dated 17.05.2023. In the report it was concluded that school management has changed name of school from Daffodils Public School to Shri Chaitanya Techno School without approval of the competent authority. It was also concluded that the fee is being charged by the school management in excess of the fee shown in FORM -VI and that the books of private publishers are being allowed in school instead of NCERT books.

Whereas, copy of report dated 17.05.2023 has been forwarded to FFRC, Hisar vide memo no. 6/64-2023 on 03.11.2023 to take action as per rule 158-A of Haryana School Education Rules, 2003 for charging fee in excess of the fee shown in FORM- VI and for allowing books by private publishers instead of NCERT books.

Whereas Rule 42 of Haryana School Education, 2003 provides for withdrawal of the recognition of school if it has changed its name without approval of competent authority. It is crystal clear from the documents available in the department and report received from the District Education officer, Fatehabad that the school management has changed the name of school without

permission of competent authority and by doing so, made itself liable for punitive action under Rule 42 of Haryana School Education Rules, 2003. Rule 42 of the said Rules is reproduced here as under:-

“42 (1)The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of commission and commission contrary to the acts/rules or directions issued their under to the managing committee either directly or through Principal/Head of the Institution

(2) The recognition/NOC of the school shall lapse if the school,-

(a) xxxxxxxx

(b) xxxxxxxxxxx

(c) Without the approval of appropriate authority—

(i) transferred to a different building or locality;

(ii)transferred to a managing committee or trust or individual or association of individuals or company;

(iii)Changes its name;

(d) xxxxxxxxxxx

(e) Has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the management of the said school as to why any action be not taken against the school under Haryana School Education Rules, 2003.

The reply, if any, the Management of school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules. Furthermore, the school management is also directed to attend hearing before FFRC, Hisar in the proceedings initiated if any on the basis of recommendations of District Education Officer, Fatehabad vide report dated 17.05.2023.


