



श्रीमती वीना तिवारी, प्रवक्ता हिन्दी को निदेशालय के आदेश क्रमांक 2/369-2017 पी0जी0टी0-11 (6) दिनांक 12.07.2021 के तहत हरियाणा सिविल (दण्ड व अपील) सेवा नियमालवली, 2016 के नियम-8 के अन्तर्गत चार्जशीट जारी करते हुए निम्नानुसार आरोपित किया गया था:-

“That you have applied for Child Care Leave w.e.f. 25.07.2018 to 02.07.2019 but, the same was sanctioned by the competent authority from 16.08.2018 to 14.10.2018, 15.10.2018 to 13.12.2018, 14.12.2018 to 14.02.2019 and 15.02.2019 to 14.04.2019. However, you remained willfully absent from duty from 26.07.2018 to 15.08.2018 and from 15.04.2019 to 02.07.2019 as your application for Child Care Leave was not approval and after 14.04.2019 your leave was not sanctioned by the competent authority.”

श्रीमती वीना तिवारी, प्रवक्ता हिन्दी द्वारा उपरोक्त चार्जशीट का जवाब दिनांक 06.09.2021 को प्रस्तुत किया गया। जिसमें श्रीमती वीना तिवारी, प्रवक्ता हिन्दी द्वारा उस पर लगाए गए आरोप निराधार, गलत व मनगढ़त बताए गए।

इसके पश्चात् तत्कालीन निदेशक सैकेण्डरी शिक्षा हरियाणा, पंचकूला द्वारा श्रीमती वीना तिवारी, प्रवक्ता हिन्दी, राजकीय वरिष्ठ माध्यमिक विद्यालय, सकेतड़ी (पंचकूला) को दिनांक 07.03.2023 को निजी सुनवाई का अवसर प्रदान किया गया तथा सुनवाई के उपरान्त आठ (8) वार्षिक वेतनवृद्धि असंचित प्रभाव से रोकने के आदेश दिनांक 14.04.2023 को पारित किए गए थे।

उक्त आदेशों के विरुद्ध श्रीमती वीना तिवारी, प्रवक्ता हिन्दी, राजकीय वरिष्ठ माध्यमिक विद्यालय, सकेतड़ी (पंचकूला) ने अपील दायर की तथा इसके उपरान्त उन्हें दिनांक 31.10.2023 को निजी सुनवाई का अवसर प्रदान किया गया।

अतः मामले का अवलोकन करने व निजी सुनवाई के उपरान्त, मैं मामले में सक्षम अधिकारी होने के नाते, तत्कालीन निदेशक विद्यालय शिक्षा हरियाणा, पंचकूला द्वारा श्रीमती वीना तिवारी, प्रवक्ता हिन्दी की असंचित प्रभाव से रोकी गई आठ वेतनवृद्धियों के आदेशों को रद्द करते हुए, उनकी एक वेतनवृद्धि असंचित प्रभाव से रोकने के आदेश पारित करता हूँ।
