





Whereas, Sh. Ramesh Kumar had filed CWP No. 18535 of 2023 titled as Ramesh Kumar vs. State of Haryana & others praying therein to direct the respondent department to promote the petitioner to the post of PGT English w.e.f. 08.01.2021 the date of the junior TGT teachers who have been given promotion with all the consequential benefits.

The Hon'ble High Court was pleased to dispose of said writ petition vide order dated 24.08.2023 with following orders/direction:-

"....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3-Director Secondary Education, to decide the pending representation of the petitioner, dated 18.04.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter."

In compliance of above said order, the representation dated 18.04.2023 of Sh. Ramesh Kumar, TGT English was perused and examined. After examination, it has been found that he was initially appointed as PRT/JBT on 05.10.2000 and later on, promoted to the post of TGT/Master (English) on 17.07.2020 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group-B) Service Rules, 2012, the qualification for promotion to the post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

By promotion:-

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND $\,$
- (ii) 2 years teaching experience as TGT English; or Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Sh. Ramesh Kumar joined as TGT English on 01.10.2020. The cut off date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021 and thereafter, again promotion cases were invited and cut off date for applying for the promotion by sending the cases through proper channel was 30.11.2021 and promotion orders were issued on 13.04.2022. On that day, petitioner did

fw

not possess the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 and 13.04.2022 reason being that they possess the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Ramesh Kumar is not tenable & the same is hereby rejected being devoid of merits.



TERMS & CONDITIONS:-

- 1. Their appointment is against a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
