Thereupon, the delinquent was being convicted and taken into custody by the Police authorities on 12.07.2022. Consequently, the delinquent was suspended w.e.f. 21.10.2021/26.11.2021 by the Department vide order No. 13/4-2021 PGT-III (1) dated 21.10.2021/26.11.2021.

Whereas, later on, Additional Sessions Judge, Special Court, Kaithal vide order dated 12.07.2022/14.07.2022, had convicted and sentenced the delinquent to undergo rigorous imprisonment for a period of three years and six months under Section 354-A and 201 of the Indian Penal Code, 1860 and to pay a fine of Rs. 25,000/- under Section-12 of the POCSO Act, 2012. Operative part of the gravity of punishments imposed upon the delinquent are mentioned as under:-

<p>Under Section 12 of the protection of Children from Sexual Offences Act, 2012.</p> <p>(Alternate punishment) (Being greater in degree than the punishment prescribed under Section 354-A of the Indian Penal Code, 1860.</p>	<p>To undergo rigorous imprisonment for a period of Three (3) years and to pay a fine of rupees twenty thousand only (Rs. 20,000/-). In default of payment of fine, he shall further undergo rigorous imprisonment for a period of four months.</p>
<p>Under Section 201 of the India Penal Code, 1860.</p>	<p>To undergo rigorous imprisonment for a period of Six (6) months and to pay a fine of rupees five thousand only (Rs. 5,000/-). In default of payment of fine, he shall further undergo rigorous imprisonment for a period of one month.</p>

Whereas, aggrieved with the above said conviction a Criminal Appeal No. CRA-S-1514-2022 of 2022 on 09.09.2022 was filed by the delinquent against order of the Additional Sessions Judge, Special Court, Kaithal before the Hon'ble High Court of Punjab and Haryana, wherein the Hon'ble High Court only suspended the sentence of the delinquent pending adjudication of appeal while granting him regular bail in lieu of surety and bail bond, but the conviction of the incumbent was never stayed/set aside. Besides that the conviction of the delinquent under serious offence comes under the purview of the moral turpitude. The Government instructions are very clear in this regard as reproduced herein below:-

"Instructions issued by the Chief Secretary to Government of Punjab vide letter No. 4819-G 11-57/11919, dated 08.07.1957 state that:-

2. Rule 7.6 of Punjab Civil Services Rules, Volume I, Part I, requires that a Government servant against whom a criminal charge is pending should be placed under suspension, if (i) the charge is connected with his position as a Government servant or (ii) is likely to prove embarrassing in the discharge of his duties as such, or (iii) involves moral turpitude. The implication of this rule is that if the criminal charge does not fall under any of these three categories, it will not be necessary to suspend the Government servant. It follows that on conviction in the case of such a charge, it will also not be necessary that the Government servant should be dismissed or removed from service. Thus rule 7.6 of the Punjab Civil Services Rules, Volume I, Part I had the effect of dividing cases in which Government servants have been convicted of criminal charges into two classes:-

(i) Cases in which dismissal or removal from service should follow automatically.

(ii) Cases in which it need not so follow."

Whereas, in the present matter, the conduct of the delinquent is covered under these instructions. Besides that, clause (a) of the provision of Article 311(2)(a) of the Constitution of India also empowers the appointing authority to dismiss without preliminary inquiry on the grounds of the proved misconduct of a Government Servant which led to his conviction on criminal charges, as in the present matter. Operative part of the said provisions is reproduced as under:-

311. Dismissal, removal or reduction in rank of persons employed in civil capacities under the Union or a State

(1)*****

(2) No such person as aforesaid shall be dismissed or removed or reduced in rank except after an inquiry in which he has been informed of the charges against him and given a reasonable opportunity of being heard in respect of those charges Provided that where it is proposed after such inquiry, to impose upon him any such penalty, such penalty may be imposed on the basis of the evidence adduced during such inquiry and it shall not be necessary to give such person any opportunity of making representation on the penalty proposed: Provided further that this clause shall not apply

(a) where a person is dismissed or removed or reduced in rank on the ground of conduct which has led to his conviction on a criminal charge; or

(b) *****

(c) *****

(3) *****

Keeping in view the above said facts and circumstances, it is observed that present matter involves the offence of moral turpitude of which the delinquent has been convicted by Ld. Additional Sessions Judge, Kaithal. Sh. Suresh Chand, PGT Political Science (now suspended) has been convicted for the aforementioned serious offences & the said conviction is still in existence. Therefore, the teacher with such a conduct is unacceptable for the

education fraternity. The delinquent should have been a role model for the society & students especially to the youths to whom he has responsibility to impart education. The delinquent has put stigma upon the pious institution, wherein everyone is expected to be a role model for young students.

Therefore, in view of the facts enunciated above, Sh. Suresh Chand, the then PGT Political Science, (now suspended) is hereby dismissed from services with immediate effect by invoking the powers conferred under Article 311(2) of the Constitution of India.



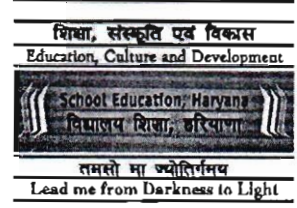


