

Appeal dated 07.06.2023 has been filed by Bharat Mata Vidya Mandir Panipat run by Rounak Education Society, Jaurasi, Samalkha, Panipat for setting aside the order dated 14.04.2023 passed by Director Secondary Education, Haryana Panchkula vide which the recognition of the said school was withdrawn w.e.f. academic session 2023-24.

Whereas vide memo no. 8/71-2023 PS (3) dated 06.11.2023, an opportunity of personal hearing was granted to the appellant school for 28.11.2023. On 28.11.2023, none appeared on behalf of appellant school. However, the District Education officer, Panipat appeared and in the course of hearing, informed that the appellant is not willing to attend the hearing in person.

Whereas, Bharat Mata Vidya Mandir, Samalkha, Panipat registered under Ronak Education Society, Jaurasi was granted NOC upto 12th level under the Haryana School Education Rules, 2003 vide order no. 23/4-2003 SI(3) dated 20.05.2004 and recognition vide order no. 23/4-2003 SI(3) dated 10.03.2004.

Whereas, an application was received in the department from Principal of Bharat Mata Vidya Mandir, Samalkha, Panipat vide memo no. BMVM3/16 dated 13.01.2020 for changing the name of school.

Rule 42 of Haryana School Education Rules, 2003 provides that a school may not change its name without approval of competent authority. It further provides for a committee for processing and recommending such application. Rule 42 is reproduced here as under:-

"Rule 42- Lapse of recognition in other cases.
(1) xxxxxxxxxxxx
(2) The recognition/NOC of the school shall lapse if the school:-
(a) xxxxxxxxxxxx

- (b) *XXXXXXXXXXXXX*
 (c) *without the approval of appropriate authority.*
(i) Transferred to a different building or locality,
(ii) transferred to a managing committee or trust or individual or association of individuals or company;
(iii) changes its name.
- (d) *XXXXXXXXXXXXX*
 (e) *XXXXXXXXXXXXX*
 (3) *XXXXXXXXXXXXX*
 (4) *XXXXXXXXXXXXX*
 (5) *The schools referred to in sub-rule (2)(c) above shall apply to the appropriate authority in an application along with documents such as resolution of managing committee, ownership of land, approved plan and an undertaking regarding any consequent liability/dispute*
- (6)(a) *There shall be a committee for processing and recommending the case consisting of following members, namely:-*
(i) Joint Director school - Chairman
(ii) District Education Officer - Member
(iii) Member of Recognized - Schools Member
- (b) *The committee shall submit its report within a period of one month and may visit the concerned school and inspect/ call for any record relevant for making recommendations.*

A committee was constituted under the chairmanship of Dr. Dilbag Singh, Joint Director. This committee submitted its report dated 21.12.2020 with the comments that:-

- i. *School is recognized for all streams but only one lab available.*
 - ii. *Fire safety certificate is not attached (renewed)*
 - iii. *Building is being used for residential purpose (one part).*
 - iv. *07 room are single doors, Conference Hall, Science Lab, Computer Lab are single door.*
- School does not fulfils norms as per details given above hence not fit for change of name of school.*

Whereas the department declined the request of the school for change of its name and the same was intimated to the school vide letter no. 17/168-07 PS (2) dated 25.06.2021.

Rule 30 of Haryana School Education Rules, 2003 provides for the conditions to be fulfilled by a private school to be recognized. The Rule 30.1 (a) (xvii), (xxix) & 30.1 (ii) (b) (f) of the Haryana School Education Rules, 2003 is reproduced here as under: -

- 30.1)(a) (xvii)** *that the school buildings or other structures or the grounds are not used during the day or night for commercial/residential purposes (except separate residence of any employee of the school away from*

academic wing) or for communal, political or non educational activity of any kind whatsoever;

30.(1) (a)(xxix) that a fire certificate shall be obtained from local fire authority;

30.(1)(b) (ii)(b) Number of classrooms shall be equal to the number of sections in the school. The classroom shall have two doors, requisite number of windows and proper ventilation;

30. (1)(b) (ii)(f) in case of middle, high and senior secondary school, the following rooms in addition to class-rooms shall be provided:-

- *Room for head of the school*
- *Office room*
- *Staff room*
- *Library room*
- *Laboratory for practical subject (according to the o stream/each subject)*
- *One room for Computer Laboratory.*
- *The school shall have atleast one computer with no demand internet connectivity for official and school management purpose;*

As per office report, the holdings placed on the school premises and buses displayed name of the school as Asha Deep Convent School on the other hand name of the school has been shown as Bharat Vidya Mandir on the letter pad of the school.

Furthermore the school is being run in clear violation of Rule 30.1 (a) (xvii), (xxix) & 30.1 (b) (ii) (b) (f) read with Rule 42 of the Haryana School Education Rules, 2003 reproduced supra.

Accordingly, the order memo no. 17/168-2007 PS(2) dated 14.04.2023 passed by the Director Secondary Education, Haryana, Panchkula, requires no interference and is hereby upheld.

Whereas, Sh. Sant Lal had filed CWP No. 21113 of 2023 titled as Sant Lal vs. State of Haryana & others praying therein to direct the respondent-Department to promote the petitioner to the post of Post Graduate Teacher (PGT) English w.e.f. 08.01.2021, the date of promotion of the junior TGT, with all consequential benefits.

The aforesaid CWP was disposed of by the Hon'ble High Court vide order dated 21.09.2023 with the following orders/direction:-

“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3/ Director, Secondary Education, Haryana, to decide the pending representation of the petitioner, dated 19.4.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”

In compliance of above said order, the representation dated 19.04.2023 of Sh. Sant Lal, TGT English was perused and examined. After examination, it has been found that he was initially appointed as PRT/JBT on 15.01.1997 and later on, promoted to the post of TGT/Master (English) on 17.07.2018.

Whereas, as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion to the post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

By promotion:-

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
 - (ii) 2 years teaching experience as TGT English; or
- Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Sh. Sant Lal had passed his degree of M.A English from Institute of Advanced Studies in Education University, Gandhi Vidhya Mandir, Sardarshar, Rajasthan being Deemed University, the same is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Government and University Grants Commission. This University did not take permission from the State

Government and University Grants Commission before opening study center to run distance education programme. In absence of the permission of University Grants Commission and State Government wherein study centers are located, the degrees obtained by the candidates from such study centers by the candidates are not legal and such candidates are not eligible for promotion as Post Graduate Teacher in Haryana Government Services.

Whereas, candidates seeking appointment had earlier filed a CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court passed an order dated 27.05.2015 and the operative part of which is as under:-

"...In view of what has been observed above, Annexures P-9 and P-10 are hereby quashed. Writ petitions are accordingly allowed. The respondents are directed to issue appointment letters to the petitioners by putting a condition in the same manner as has been put while issuing appointment letters to the candidates who have challenged the exemption clause vis-à-vis sitting in HTET/STET examination forthwith. The respondents are also directed to issue re-appointment letters to the petitioners, whose services have been dispensed with by putting the same condition."

It is further submitted that LPA No. 1215 of 2015 was filed against CWP No. 7626 of 2015 and the same was later on withdrawn by the Department with the liberty to file a Review Application against the order dated 27.05.2015 which was dismissed on the grounds of delay. Later on, the Department again filed LPA No. 171 of 2021 and which was again dismissed on the grounds of maintainability. Now the matter is pending in the Hon'ble Supreme Court vide SLP No.017134/2021. However, the petitioners have placed reliance upon the judgment passed in CWP No. 7626 of 2015, In this regard, it is stated here that CWP No. 7626 of 2015 pertains to the fresh appointments of PGTs whereas the grievance of the petitioner in the present matter relates to promotion to the post of PGT.

Whereas, similar situated employees had filed CWP No. 15843 of 2018, which was allowed by Hon'ble High Court on 16.10.2019. Thereafter, the department filed the LPA No. 19 of 2021 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 16.10.2019 & the matter is now subjudice wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the order dated 26.02.2021 is reproduced here as under:-

"Issue notice in the main appeal as well as in the application for condonation of delay in filing the same."

Mr. Ranjit Singh Kalra, learned counsel on the strength of caveat accepts notice on behalf of respondent No. 1.

List on 25.05.2021 alongwith LPA-626-2020.

In the meanwhile, operation of the impugned judgement dated 16.10.2019 passed by the learned Single Judge in CWP-15843-2018 shall remain stayed."

Keeping in view the facts mentioned above, documents on record and order of Hon'ble Division Bench, the claim of Sh. Sant Lal is not tenable & same is hereby rejected being devoid of merits.

Ordered accordingly.
