Whereas, the petitioner had filed the CWP No. 9272 Of 2023 titled as Surender Kumar Vs State of Haryana & others, before the Hon'ble High Court praying therein for issuance of a writ in the nature of certiorari quashing the impugned action of the respondents vide which the claim of the petitioner for grant of Old pension scheme and other benefit counting the ad-hoc service followed by regular service has not been considered. The further prayed for issuance of writ in nature of mandamus to re-fix the date of regularization after counting the service rendered during part time period to as per the judgment of Harbans Lal from the date of initial appointment and to grant the consequential and all ancillary benefits including allotment of General Provident Fund Account Number.

The above-said Civil Writ Petition came up for hearing on 01.05.2023 & the same was disposed of by the Hon'ble High Court with the direction to decide the legal notice of the petitioner. The operative part of the said order is as under:-

“In view of the request made, without expressing any opinion on the merits of the case, respondent No.2-Director, Secondary Education, Haryana, is directed to decide the legal notice dated 15.12.2022 (Annexure P-7) by passing a speaking order within a period of eight weeks from the date of receipt of certified copy of this order, in accordance with law. Disposed of.”

In compliance to the aforesaid directions of the Hon'ble High Court, the legal notice dated 15.12.2022 (Annexure P-7) of the petitioner was examined and after examination, it has been found that the petitioner was

ju

initially engaged as Part-time class IV on 08.01.2001 to the post of Kahar in Govt. Girls Primary School, Nirjan, District Jind against un-sanctioned post.

Whereas, earlier, the Education Department had its own regularization policy dated 30.12.1998/25.02.1999, which was superseded by the new regularization policy of dated 11.11.2003. In context of regularization of the services of the petitioner under the New Departmental Policy dated 11.11.2003, it is hereby clarified that as per the departmental regularization policy dated 11.11.2003, a common seniority list of all the part time Class-IV employees working in Govt./ Primary/Middle/High/Sr. Secondary Schools and the field offices like O/o BEOs/ SDOs/DPEOs/DEOs/SCERT/DIETs/GETTIs etc as on 30.06.2003 was prepared by the DEOs concerned at District Level and this seniority list of part time Class-IV employees acts as a reference point for sponsoring the names of the senior most person for regularization against the regular sanctioned post of Class-IV in the field offices/Schools of the Education Department. Therefore, on completion of the tenure of part time service mentioned in the policy dated 11.11.2003, the part time Class-IV employees are regularized from time to time on the basis of the above said seniority list provided they would fulfil the prescribed qualification for other Class-IV posts.

Further, services of the petitioner were regularized vide order no.E-3/2018/Appointment/172-222 dated 16.02.2018 of District Education Officer, Jind, as per his seniority, eligibility and on the availability of vacant regular sanction post of class IV, under the regularization policy dated 11.11.2003 (department specific policy), wherein the seniority list of part time class IV employees was made at District level and accordingly the petitioner stands at Seniority Number 115. The petitioner joined to the regular post of kahar-cum-Mali on 24.02.2018 in Government High School, Budain, District Jind. So, the petitioner is entitled to get the benefits as regular employee w.e.f. 24.02.2018 onwards and not prior to that.



Whereas, as per State Govt. notification dated 18.08.2008, New Pension Scheme came-into force, which is applicable to the employees, who have joined on regular basis on or after 01.01.2006 and the petitioner had joined as regular employee on 24.02.2018. Therefore, on the basis of "New Pension Scheme", the PRAN Number was allotted to him and he had also deposited his share of NPS amount. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable to him.

Further, as per Rule 3.17-A(g) (iii) of Punjab Civil Service Rules Volume-II, the service period rendered as "PART TIME" employee cannot be computed for pension & pensioner benefits. Relevant portion of the same is reproduced as under.

Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

- (1) Such service is followed by regular employment.**
- (2) There is no interruption in the two or more spells of services or the interruptions fall with-in condonable limits: and**
- (3) Such services is a whole time employment and not part-time or portion of day.**


In view of the above-mentioned facts, the case of the petitioner cannot be considered under Old Pension Scheme as the petitioner was entitled for regularization from 16.02.2018, therefore he is entitled to get the benefits of New Pension Scheme which was prevalent at the time of regularization of the petitioner and accordingly, the benefits of New Pension Scheme have already been granted/released to the petitioner. Further, for the purpose of getting benefits under the Old Pension Scheme, the person has to serve as a regular employee within the prevalence of Old Pension Scheme and the same is discontinued from 01.01.2006 onwards and the petitioner was regularized after said date. Therefore, he is not entitled to get the benefits of Old Pension Scheme.

Further the petitioner has quoted the reference of Harbans Lal's case in the present writ petition. In this regard, it is clarified here that the case of Harbans Lal was allowed on the basis of work charged employee in the State of Punjab, but the petitioner was appointed as part time class-IV on 08.01.2001 to the post of Kahar in Govt. Girls Primary School, Nirjan, District Jind against un-sanctioned post. So his case is not covered under the judgment of Harbans Lal.

Keeping in view of the position explained above, the claim of the petitioner demanded through Legal Notice dated 15.12.2022 (Annexure P-7) is not tenable. Hence, the claim of the petitioner is hereby rejected being devoid of merits.

Whereas, the petitioner had filed a CWP No. 19413 of 2023 titled as "Kitabo devi V/s State of Haryana and others in the Hon'ble Punjab and Haryana High Court, praying therein for the issuance of direction to the respondents to grant all arrears of pay and consequential benefits by counting her past service as regular service along with interest @ 12% p.a. and further to release pay of the petitioner w.e.f. 01.04.1999 when her services were regularized along-with other service & consequential benefits and also prayed for direction to the respondents to decide the legal notice dated 15.12.2022 (Annexure P-6).

The above said writ petition came up for hearing before the Hon'ble High Court on 02.09.2023 and the same was disposed of with the direction to decide the legal notice dated 15.12.2022 of the petitioner. The operative part of the said order is reproduced as under:-

"Without going into the merits of the case, the present petition is disposed of with a direction to respondent No.1- Director, Department of School Education, Haryana, to consider and decide the pending legal notice dated 15.12.2022 (Annexure P-6) by passing a speaking order thereupon, within a period of two months from the date of receiving a certified copy of this order."

Whereas, in compliance of the above said order passed by the Hon'ble High Court, the legal notice dated 15.12.2022 (Annexure P-6) of the petitioner has been examined and it has been found that the petitioner namely Smt. Kitabo Devi was engaged as part time class-IV employee on 28.07.1993 in the GPS Barodh, District Jind only for ½ to 2 hours. Earlier, the petitioner had filed the CWP No.10724 of 2000 titled as Kitabo Devi vs. State of Haryana & Others and the same was disposed of by the Hon'ble High Court on 17.08.2000

and the operative part of the order dated 17.08.2000 is reproduced as under:-

“We have heard the counsel and perused the rival contentions. We find that the petitioner is required to seek remedies available under law before approaching this court by way of writ petition. If so advised, the petitioner may approach the respondents by filing representation as per the ground taken in this writ petition. If any such representation is filed, the same shall be duly considered and decided by passing a speaking order by the concerned authorities expeditiously. The writ petition is not entertained on the ground that the petitioner has not availed the other remedies available under the law.”

In compliance of above said order, the petitioner represented to the Department for regularization and reinstatement of her services, but the claim of the petitioner was rejected by way of passing of speaking order No.E-2000/610-614 dated 19.12.2000 of Block Education Officer, Saffidon District Jind. But the petitioner had filed COCP No.164 of 2012 titled as Kitabo Devi vs. Smt. Surina Rajan & Others for non-compliance of order dated 17.08.2000 passed in CWP No.10724 of 2000 titled as Kitabo Devi vs. State of Haryana & Others, which was listed for hearing on 19.01.2012, wherein, the Hon'ble High Court passed the interim orders which is reproduced as under:

“Depute some official to collect copy of contempt petition from this office and file necessary compliance report or reply explaining the reasons for non-compliance of order passed by the Hon'ble Court before the next date of hearing.”

Thereafter, the petitioner namely Kitabo Devi was regularized notionally w.e.f. 01.01.1999 and actually on 24.02.2012 in light of the policy dated



30.12.1998/25.02.1999 vide order No.E-2/2012/455-458 dated 13.02.2012 of Office of District Education Officer, Jind and the contempt petition was disposed of on 22.02.2012 with a clarificatory direction. The operative part of the order dated 22.02.2012 is reproduced as under:-

Learned State counsel has placed on record a copy of the order dated 13.02.2012 whereby the services of the petitioner have been regularized w.e.f. 1.4.1999. Since substantial relief has been granted, the contempt petition is disposed of with a clarificatory direction that the consequential notional benefits be also released to the petitioner within a period of three months from the date of receiving a certified copy of this order.

In compliance of above said direction, the pay of the petitioner was fixed notionally from the date of regularisation i.e. 01.04.1999 and actual from the date of joining i.e. 24.02.2012 with condition that the petitioner would not be entitled for arrears of pay from the deemed date of regularization to the actual date of joining.

Whereas, the detail of the petitioner has been given under in the tabular form:-

Further, it is clarified here that 1st ACP w.e.f 01.04.2009 after completion of 10 years of regular satisfactory service and 2nd ACP w.e.f 01.04.2015 after completion of 16 years of regular satisfactory service has

already been granted to the petitioner vide Order No. 91-92/2013 dated 30.08.2013 and Order No. A-III/2015 dated 09.11.2015 was granted to her. But as far as promotion is concerned, for that the petitioner is not eligible, because she is illiterate and minimum qualification for promotional post is matriculation.

Therefore, keeping in view the above mentioned facts and circumstances of the case, the claim of the petitioner demanded through legal notice dated 15.12.2022 is not tenable. Hence, the claim of the petitioner demanded through legal notice date 15.12.2022 is hereby rejected being devoid of merits.

State of Haryana & Others" before the Hon'ble Punjab and Haryana High Court at Chandigarh praying therein for issuance of a writ in the nature of Mandamus directing the respondents to allot the legal notice dated 23.04.2023 (Annexure P-12) and to allot GPF accounts instead of CPF accounts to the petitioners.

The above said writ petition came up for hearing on 05.10.2023 and the same was disposed of by the Hon'ble Court with the direction to decide the legal notice of the petitioners. The operative part of the said order is as under:-

"In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No. 2/ Commissioner-cum-Director General, School Education, Haryana, to consider and decide the pending legal notice, dated 23.04.2023, by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order."

In compliance of the above said direction of the Hon'ble High Court, the case record and legal notice dated 23.04.2023 of the petitioners was examined. After due examination of the matter, it has been found that the petitioners were engaged as Part time class-IV employees in the different schools in District Jind in the years 1994, 1996 & 2000 as per the prevailing DC rates only for one and half hours per day. The services of the petitioners were regularized in the years 2012 & 2014 in light of the policy dated 11.11.2003 on the basis of their seniority as well as eligibility as and when sanctioned posts were available in the School subject to the fulfilment of the terms and conditions of the policy dated 11.11.2003. However, a detailed description regarding the petitioners is here as under:-

Primary/Middle/High/Senior Secondary School and field offices like o/o BEOs/DEOs/DPEOs etc. as on 30.06.2003 for regularization of their services against vacant regular sanctioned post. As per district level seniority list the petitioners stand at different serial numbers i.e. 265, 263, 278 and 432 & hence regularized in the year 2012, 2014 & 2015 as per their entitlement.

Whereas, as per State Government Notification dated 18.08.2008 of Finance Department of Government of Haryana, New Pension Scheme came-in-to force, which is applicable to the employees, who has joined as a regular employees on or after 01.01.2006 and the petitioners had joined as a regular employees after 01.01.2006 i.e. in the year 2012 & 2014. So, New Pension Scheme is applicable to the petitioners. Therefore, on the basis of "NEW PENSION SCHEME", the PRAN numbers were allotted to them and they had also deposited their share in their NPS account. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable in the cases of the petitioners.

Therefore, keeping in view the above said facts & circumstances of the case, the claim of the petitioners demanded through legal notice dated 23.04.2023 (Annexure P-12) is not tenable & hence liable to be rejected.



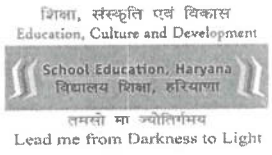
