In pursuance with instructions of Chief Secretary, Haryana issued vide No. 22/10/2013-1GS-III dated 17/19.04.2017, 01.07.2022 & 11.08.2023 and amended from time to time and in compliance of orders dated 22.12.2023 passed by the Hon'ble State Commissioner for Persons with Disabilities, Department of Social Justice and Empowerment, Haryana in case No. CD-431/2023 titled as Lalit Rupesh Vs ACS School Education and other, Sh. Lalit Rupesh [036885] (Seniority No. 2233 of PGT as stood on 08.07.2019 & 627 as per Divyang seniority) , Post Graduate Teacher in Physics, Government Girls Senior Secondary School, Kharak Kalan [331] (Bhiwani), (HH Category) is hereby granted deemed date promotion to the post of Principal (Rest of Haryana Cadre) (School Cadre) w.e.f. 04.08.2021 (under 4% reservation in RPwD Quota with benefit of notional pay fixation although he is not entitled for arrears for the period in which he has not actually worked as Principal) subject to the final outcome of CWP No. 16334 of 2021 titled as Lalit Rupesh Vs State of Haryana and others, in the pay scale notified under Haryana Civil Services (Pay) Rules 2016. On promotion, he is temporarily posted at Govt. Sr. Sec. School Kalinga [330] (Bhiwani) against vacant post subject to the condition that he will participate in the next General Transfer Drive, as per following terms & conditions:-

1. In case the claim belonging to disability certificate of any employee is found false and fabricated at any stage later on, he/she would be reverted without any notice and without any prejudice to such further disciplinary action as may be initiated under the provision of the Indian Penal Code for production of such false/fabricated documents.
2. The Roster point allotted to the aforesaid officers is provisional and can be changed/amended/alterd, if required on the basis of any legitimate claim of some other or any of the PGTs in the cadre.
3. In addition to these candidates, if claim of another Divyang PGT is found legitimate in respective category, the junior most would be reverted without a notice and concerned senior disabled PGT would be considered.
4. There should be no charge sheet under Rule-7/8 of HCS (Punishment & Appeal) Rules, 2016 and vigilance enquiry pending against the above mentioned officials as on date on the promotion/deem date promotion.
5. The above promotions/deem date of promotion is subject to the condition that if any adverse remarks are found later on in the ACR's which are not presently available in the office records, the officials concerned will be reverted back immediately, without assigning any reasons.
6. That above promotion/deem date of promotion is found senior to the officials being promoted junior most will be reverted without assigning any reason.
7. That this promotion is being made effected on the basis of provisional seniority list of Divyang PGTs and any change in the list may result in reversion of an official if it is found that a person senior to him has been left out for want of certain information/record.
8. That this promotion is without prejudice to the right of his senior if any who have been ignored for want of certain information/record.
9. That the official should not be relieved/joined on promotion post during the currency of the stoppage of grade increment(s).
10. That the official should not be relieved/joined on promotional post without checking their Unique Disability Identity Card issued by the Govt. of India. Only permanent Disability Card accepted.

11. The above promotion is subject to the final outcome of CWP No. 21481 of 2019 titled as Prahlad Singh Vs State of Haryana, 2631 of 2021 titled as Shamsher Singh Khatri Vs State of Haryana, CWP No. 2607 of 2021 titled as Sunder Lal Vs State of Haryana, CWP No. 6245 of 2018 titled as Krishan Kumar Vs State of Haryana, 10934 of 2022 titled as National Blind Association Vs State of Haryana 29326 of 2019 titled as Surender Vs State of Haryana & CWP No. 9975 of 2022 titled as Vijay Kumar Jindal & Others.
12. The candidate will not claim any arrear of pay on account of his/her notional promotion and only notional benefits of pay fixation will be granted. He/She would be granted actual benefit of pay fixation from actual date of joining of promotional post.
13. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the Haryana State Education School Cadre (Group-B) Service Rules, 1998 & Haryana State Education School Cadre (Group-B) Service Rules, 2012 amended in 2014, the said incumbent(s) shall be reverted without issuing any notice.
14. The newly promote(s) Principal will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
15. After promotion, seniority of these officers will be determined as per instructions rules issued or notified by the Govt. of Haryana, School Education Department from time to time.
16. The newly promotee PGTs shall have to seek permanent posting through One School portal by participating next Transfer Drive.
17. The promotions under these instructions have been granted to the persons with disabilities who may be junior to others in the seniority list. No benefit of stepping up of pay or pay scale shall be admissible to others who were/are senior to him/her in the PGT Cadre.

Whereas, Smt. Anita Ahlawat had filed CWP No. 18867 of 2023 titled as Anita Ahlawat vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent-Department to promote the petitioner to the post of Post Graduate Teacher (PGT) English w.e.f. 08.01.2021, the date of promotion of the junior TGT, with all consequential benefits.

The aforesaid CWP was disposed of by the Hon'ble High Court on 05.09.2023 with following orders/direction:-

“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, Annexure P-4, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”

In compliance of above said order, the representation dated 30.03.2023 of Smt. Anita Ahlawat, TGT English was perused and examined. After examination, it has been found that she was initially appointed as PRT/JBT on 09.07.2004 and later on, promoted to the post of TGT/Master (English) on 17.07.2018.

Whereas, as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion to the post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

By promotion:-

(i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND

(ii) 2 years teaching experience as TGT English; or

Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Smt. Anita Ahlawat had passed her degree of M.A English from Vinayka Mission University, Salem, Tamil Nadu. Vinayka Mission University, Salem, Tamil Nadu being Deemed University, is not competent to run the distance education programme beyond their territorial jurisdiction without the

fu

permission of State Government and University Grants Commission. This University did not take permission from the State Government and University Grants Commission before opening study center to run distance education programme. In absence of the permission of University Grants Commission and State Government wherein study centers are located, the degrees obtained by the candidates from such study centers by the candidates are not legal and such candidates are not eligible for promotion as Post Graduate Teacher in Haryana Government Services.

Whereas, candidates seeking appointment had earlier filed a CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court had allowed the CWP vide passed order dated 27.05.2015. Now, the matter is pending in the Hon'ble Supreme Court vide SLP No.017134/2021. However, the petitioners have placed reliance upon the judgment passed in CWP No. 7626 of 2015, In this regard, it is stated here that CWP No. 7626 of 2015 pertains to the fresh appointments of PGTs whereas the grievance of the petitioner in the present matter relates to promotion to the post of PGT.

Whereas, similar situated employees have filed CWP No. 15843 of 2018, which was allowed by Hon'ble High Court on 16.10.2019. Thereafter, the department filed the LPA No. 19 of 2021 before the Division Bench of the Hon'ble High Court against the said order of Single Bench dated 16.10.2019 & the matter is now subjudice wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the order dated 26.02.2021 is as under:-

“Issue notice in the main appeal as well as in the application for condonation of delay in filing the same.


Mr. Ranjit Singh Kalra, learned counsel on the strength of caveat accepts notice on behalf of respondent No. 1.

List on 25.05.2021 alongwith LPA-626-2020.

In the meanwhile, operation of the impugned judgement dated 16.10.2019 passed by the learned Single Judge in CWP-15843-2018 shall remain stayed.”

Keeping in view of the facts mentioned above & documents on record, the claim of Smt. Anita Ahlawat is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.

Whereas, Smt. Sangeeta had filed LPA No. 316 of 2023 titled as Sangeeta vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct respondent Nos. 1, 2 and 4, to decide the representation dated 02.01.2023 within a stipulated time.

The Hon'ble Division Bench disposed of said LPA vide order dated 22.03.2023 with following orders:-

“After arguing at length, learned counsel for the appellant submits that a representation dated 02.01.2023 (Annexure P-10) with regard to her grievances is still pending and no decision thereon has been taken as yet by the authorities.

Learned Additional Advocate General appearing for the respondent-State of Haryana submits that in case any representation filed by the appellant is pending with the authorities, the same shall be considered and decided in accordance with law.

In view of the above, the appeal is disposed of.”

In compliance of above said order, the representation dated 02.01.2023 of Smt. Sangeeta was duly examined and after examination, it is found that she had applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') – Mathematics against the advertisement no. 4/2015 under BC-B.

Whereas, the Directorate of School Education Department sent a requisition to the Haryana Staff Selection Commission, Panchkula (henereinafter called HSSC) for selection and recommendation of the names of eligible candidates for the post of PGT Mathematics. Accordingly, HSSC advertised the said posts vide Advertisement No. 04/2015 dated 28.06.2015.

Whereas, in compliance of the order dated 01.09.2021 passed by the Hon'ble Apex Court in SLP No. 25184-25214 of 2018 titled as Haryana Staff Selection Commission vs. Priyanka and others, the name of the petitioner was recommended by the HSSC, Panchkula for the post of PGT Mathematics vide memo No. HSSC/Conf./Recomm./2022/142 dated 23.02.2022 and afterwards, the Department issued the appointment to the applicant vide order dated 02.03.2022.

Furthermore, the Department gave the extension to her till 17.06.2022 as per the request of the applicant. Meanwhile, the Hon'ble Apex Court clarified the order dated 01.09.2021 vide order dated 09.05.2022 in MA No. 539-569 of 2022 in Civil Appeal No. 5065-5095 in SLP No. 25184-25214 of 2018. The

operative part of the order dated 09.05.2022 is as under:-

“.....Until the Commission carries out the requirements of this order and recasts the merit position and the eligible candidates are issued fresh offer of appointment, status quo as existing today shall be maintained. However, after recasting the merit list, the cases of those candidates who have been given the offer of appointment pursuant to the orders passed by this Court earlier but are to be denied appointment due to merit standing, may be considered for accommodation against the existing vacancies, but only in accordance with law.”

Whereas, in compliance of the abovesaid order, the Department has decided that the low merit candidates will not be considered for appointment to the post of PGTs and later on, the HSSC withdraw the recommendation of low merit candidates vide Memo No/Confid./13/02/2022-9CA/814 dated 20.09.2023. Now, the Department will withdraw the appointment of the candidates who are lower in merit.

Keeping in view of the above, the claim of the applicant demanded through representation dated 02.01.2023 could not be accommodated and she cannot be allowed to join to the post of PGT Mathematics.

I order accordingly.
