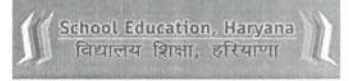

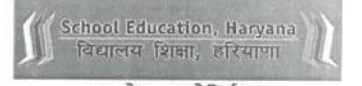

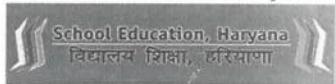

Whereas, the petitioner had filed Civil writ petition No. 17871 of 2023 titled as Angrej Singh Vs. State of Haryana and others, with the prayer to issue order/direction to respondents to consider claim of the petitioner for promotion to the post of 'Resource Executive' with effect from 09.12.2021 which has been kept vacant in School Education Department Haryana even having fulfilled all the requisite educational qualifications and experience. Further, he has requested that one post of Resource Executive may be kept vacant during pendency of present civil writ petition and he has also requested to assign actual job/ duties of "Private Secretary" to petitioner instead of superintendent as duties and liabilities of "Private Secretary" and 'Superintendent' are identically different.

The Hon'ble High Court was pleased to dispose of the aforesaid writ petition vide its order dated 25.08.2023. The operative part of the order is reproduced here as under:-

***"In view thereof, without going into the merits of the case, the instant petition is disposed of with a direction to respondents, to consider and decide the pending representation, dated 15.05.2023, by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order."***

In compliance of the aforesaid directions of the Hon'ble High Court, the representation of the petitioner dated 15.05.2023 has been examined and it has been found that five posts of Resource Executive were created by the department in the year 2018 and since then these post are lying vacant. However, after receipt of representation from Sh. Angrej Singh, a Committee was constituted by the Department to prepare the draft of Service Rules for the post of Resource Executive. Subsequently, the matter along with the Draft Service Rules as submitted by the Committee was put up for approval from the

ju

Hon'ble Chief Minister of Haryana, however, certain observations were raised by the authorities at that time.

Whereas, again on 17.08.2023, a proposal to seek approval from Hon'ble Chief Minister on Draft Service Rules (Resource Executive) with further proposal to convert the two posts into Assistant Director (Academic) and two posts into Assistant Director (Ministerial Cadre) out of 05 posts was put up, however, due to the fact that the meeting for rationalization of posts was held and as its report was pending, it was directed to keep the matter pending till receipt of the rationalization committee report.

Whereas, various observations were made by the authorities in the Draft Service Rules prepared earlier, a Committee comprising of Chief Accounts Officer, Assistant Director and Assistant District Attorney has been reconstituted vide order dated 02.11.2023 to Re-draft the Service Rules for the post of Resource Executive.

Hence, the claim of the petitioner for promotion to the post of Resource Executive could not be decided till the finalization of the Service Rules for the post. Once the Service Rules are finalized, the promotion to the eligible candidates will be granted subject to their eligibility amongst all the eligible candidates from Higher and Secondary Department being Common Seniority.

Whereas, the contention of the petitioner that he fulfills the requisite educational qualifications and experience for this post is not tenable as the requisite educational qualifications and experience will be decided as per the Service Rules to be notified for this post which are under consideration.

Further, the petitioner in his representation dated 15.05.2023 has also requested to assign actual job/ duties of "Private Secretary" to him instead of superintendent by relying on the contention that the duties and liabilities of "Private Secretary" and "Superintendent" are identically different.

Whereas, the petitioner possesses the vast experience in major functioning of the department, therefore, the competent authority after due consideration has assigned him the duty of supervising the most important

fu

branch of the department i.e Coordination Branch. The Coordination branch holds a major role in the department like framing of rules, providing information regarding Vidhan Sabha questions etc. As all the important/major work is done by that branch, therefore, as per the capability, the petitioner has been allotted the duty to supervise the Principal branch of the department. Hence, in view of above facts, the claim of the petitioner for promotion cannot be considered till the finalization of Service Rules for the post of Resource Executive. Moreover, it is a settled law that promotion is not a matter of right of an employee. Thus, the claim of the petitioner, at this stage, is not tenable and liable to be rejected.

I pass the order accordingly.

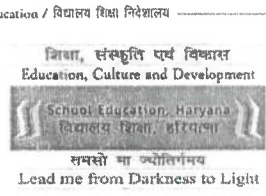

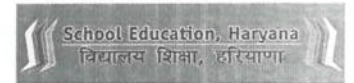

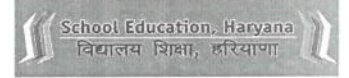
