Finance Department observes as under:-

- The Hon'ble Punjab & Haryana High Court has disposed of the CWP No. 12453 of 2017-Satyapal & Others Vs. State of Haryana vide its orders dated 12.10.2023 on the same terms and conditions passed in Civil Appeal No. 2471 of 2023 titled as "The Director KPTCL & Others Vs. C.P. Mundinamani and others" decided on 11.4.2023.
- After consideration, the Administrative Department had been advised on 08.11.2023 to file LPA against the orders dated 12.10.2023.
- Further, Ld. Advocate General, Haryana vide its opinion dated 19.12.2023 has opined that the matter is fit for filing LPA.
- Accordingly, a general Instruction dated 04.01.2024 has been issued/ uploaded on the website of Finance Department i.e. [www.finhry.gov.in](http://www.finhry.gov.in), wherein it has been advised to immediately file LPA(s) in the Hon'ble High Court against the judgment(s) passed by the Hon'ble High Court/ Ld. Court(s) in respective petitions.

Therefore, the Administrative Department is advised to take necessary action as per General Circular/ Instruction dated 04.01.2024 in all the pending/ disposed of CWPs/ cases, wherein it has been requested/ prayed to grant the notional increment which fell due on 1<sup>st</sup> July on completion of 12 months of service on 30<sup>th</sup> June of Calendar year (After retirement) and defend the cases/ LPAs in Hon'ble Courts in effective manner.
