


### HARYANA GOVERNMENT EDUCATION DEPARTMENT CHANDIGARH



#### ORDER

On the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No. HSSC/Confd./Recomm./01/38/2023/800 dated 12.09.2023, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Commerce** (HES-II) (Rest of Haryana cadre) against Advt. No. 4/2015 in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 – 1,51,100/- plus usual allowances as admissible from time to time. He is directed to join at the place of posting as mentioned against his name as under:-

#### Terms and conditions:-

- 1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
- 2. The benefit of notional pay fixation and seniority will be admissible w.e.f. 22.02.2019 from the date when his/her juniors have been appointed and actual financial benefits will be admissible to him/her from the date when he/she joins duty as **PGT Commerce**.
- 3. The candidate shall have to take an oath of allegiance to the Constitution of India.
- 4. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
- 5. The candidate shall not claim seniority on the basis of this order. His/her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.

The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one 6.

In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 7. applicable to Haryana Government Employee orders/instructions as may be issued by the Government from time to

- In case of reserved category candidate, the appointment is provisional 8. and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
- The candidate is hereby directed to produce his/her original 9. certificates of academic qualifications and other relevant certificate to District Education Officer concerned alongwith self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
- Medical fitness certificate issued by the concerned Civil Surgeon will 10. be produced before the joining.
- The candidate shall be governed by the Haryana State Education 11. School Cadre (Group-B) Service Rules-2012.
- If at any time during the course of temporary appointment, the 12. candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
- No TA/DA will be admissible to the candidate for joining as PGT. 13.
- If the candidate gets an appointment as PGT on the basis of 14. furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
- This appointment letter is provisional subject to the condition of good 15. moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
- 16. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the selfdeclaration, the provisional appointment letter will be cancelled fortwith and other criminal/legal action will also be taken as per provisional of Indian Penal Code (IPC) etc as deemed fit.

- 17. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/08/2022-3GS-III dated 23.06.2022.
- 18. The concerned candidate is directed to join duties at place of posting within 15 days and send the joining report (duly signed by DDO) at <a href="mailto:dsepgt1@gmail.com">dsepgt1@gmail.com</a>, failing which this offer of appointment letter will be deemed to have been withdrawn.
- 19. If the candidate is willing to accept this offer of appointment as PGT HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
