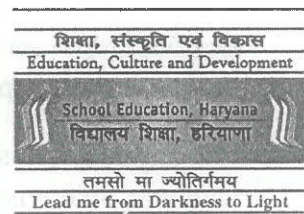

- These Headmasters will be entitled for benefits of promotion i.e. pay and seniority w.e.f. the date of promotion of their juniors, as mentioned above, notionally and actually from the date of joining duty on post of Headmaster. It is also clarified that the service on post of Lecturer would be considered as 'ex cadre service' and pay fixation would be done in accordance to Master cadre pay scale.
