Appeal dated 22.12.2023 has been filed by President, Bahadurgarh Shiksha Sabha, Bahadurgarh for setting aside the order dated 02.11.2023 passed by Director Secondary Education, Haryana Panchkula vide which the recognition of the said school was withdrawn w.e.f. academic session 2024-25.

Whereas, Sh. Mohit Gupta & others filed various complaint before Director Secondary Education alleging that the said school is running separate branches without getting any permission/ approval from the competent authority.

Whereas, Vaish Arya Kanya Sr. Sec. School, Bahadurgarh, Jhajjar was granted permanent recognition for upto 5th level vide order dated 01.07.1948, upto 8th level vide order dated 09.08.1961 and subsequently granted additional permanent recognition in Science Stream vide order 14/7-09-PS(1) dated 20.07.2009.

Whereas an opportunity of personal hearing was granted to the appellant school for 03.01.2024. On 03.01.2024, Shree Niwas Gupta appeared on behalf of appellant school. In course of hearing, appellant submitted that initially Vaish Kanya Pathshala was granting recognition upto 5th class with respect to premises located at Railway Road, Bahadurgarh and Vaish Kanya Pathshala has been running from this premises located at railway road, Bahadurgarh since 1948. He further submitted that Vaish Arya Kanya Sr. Sec. School, Bahadurgarh, Jhajjar was granted separate recognition for higher classes with respect to premises in Bahadurgarh at Mal Godam Road.

Whereas revenue record of the land, where Vaish Kanya Pathshala is being run, was placed on record. The revenue record of premises for the years 1971-72, 1976-77, 1981-82, 1986-87, 1996-97, 2016-17 and 2021-22, depicts that land type with khasra/killi no. 73//26(1-15), 141 (14-6) is *gair mumkin* Pathshala. Furthermore Vaish Kanya Pathshala was recognized upto class 5th

for premises in Bahadurgarh, however, specific address has not being mentioned in the recognition certificate. The complainant/ respondent failed to controvert Vaish Kanya Pathshala is the school that is being run at the premises located at railway road Bahadurgarh since 1948. Recognition certificate upto 5th class when observed in light of revenue record led to reasonable presumption that Vaish Kanya Pathshala was recognized upto 5th class for its separate premises located at Railway Road Bahadurgarh and separate recognition for higher classes was granted with respect to school premises located at Mal Godam Road, Bahadurgarh. Furthermore, there are approximately 605 students (107 Students upto 5th Class and 498 Students in 6th to 12th Class) presently studying in schools at a minimal fee of Rupees 50/- per month for primary wing, Rs.500/- per month for Upper Primary Stage, Rs. 900/-per month for Secondary Stage and Rs. 1600/- per month for Senior Secondary Stage. Also the schools have been running ^{for the last} since many years and providing its services to the society in an appreciated ^{ble} manner. There is no complaint against the school management regarding the administration of schools.

In view of facts mentioned above, pleadings and official record, I am of opinion that future of 607 students cannot be put in jeopardy, that too when the Department of School Education is meant to promote education and not to contain it. Accordingly, the order memo no. 6/44-2023 PS(4) dated 02.11.2023 passed by the Director Secondary Education, Haryana, Panchkula is annulled and order for closure is hereby canceled.


