



Whereas, Sh. Rajbir Singh, the then Clerk, GHS Khatoda, Mahendragarh now Clerk (Retd.) O/o DEEO Narnaul, was chargesheeted U/R-7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 on 04.06.2003/30.06.2003, wherein the following charges were levelled against him:-

Further, he was again chargesheet U/R-7 on 27.10.2009 with the following charges:-

- 1. कि उसने सहायक के पद पर पदोन्नित हेतू अपना मामला मुख्यध्यापक रा०उ०िव खातो दड़ा (महेन्द्रगढ) तथा तत्कालीन उपमण्डल शिक्षा अधिकारी, नारनौल के द्वारा तैयार करवाकर जिला शिक्षा अधिकारी, नारनौल के माध्यम से निदेशालय को भिजवाया। जबिक उसके विरुद्ध थाना महेन्द्रगढ में भारतीय दण्ड संहिता की धारा 323, 325, 34 के अन्तर्गत दिनांक 14.05.2002 को पृष्ट संख्या 139 के अनुसार अपराधिक मामला दर्ज हुआ था।
- 2. कि उसने उसके मुख्याध्यापक से उसके विरुद्ध कोई शिकायत या जांच लंबित नहीं होने का प्रमाण पत्र तथा कोई कोर्ट केस लंबित नहीं होने का प्रमाण पत्र तैयार करवाते हुए उपमण्डल शिक्षा अधिकारी, नारनौल से प्रतिहस्ताक्षर करवाकर पदोन्नित मामले के साथ सलग्न किये। उन प्रमाण पत्रो पर मुख्याध्यापक की मोहर के नीचे तथा उपमण्डल शिक्षा अधिकारी की मोहर के नीचे उसने स्वयं इनिशियल किये है।
- 3. कि उसने उपरोक्त क्रम न.1 एंव 2 अनुसार कार्यवाही करते हुए स्वंय जानबूझकर विभाग को धोखा देते हुए सहायक के पद पर पदोन्नित प्राप्त की।

The delinquent submitted his reply to the above said chargesheets on 16.07.2003 and 11.11.2009 respectively. Thereafter, Sh. V.P Batra (Retd. IAS) was appointed as Inquiry Officer in this matter on 04.01.2010/15.02.2010 to hold regular departmental enquiry. The inquiry officer submitted the enquiry report on 20.05.2010 wherein the charges levelled against the delinquent were found to be proved, resultantly a notice dated 12.04.2012/28.04.2012 was issued to the delinquent for stoppage of two increments with cumulative effect and thereby sought his representation within 15 days of the said notice.

Thereafter vide order dated 20.09.2012/03.10.2012, the competent authority confirmed the aforesaid notice & awarded a penalty of stoppage of one increments with cumulative effect.



Thereafter, on 24.09.2021 an appeal was filed by Sh. Rajbir, Clerk against the order dated 20.09.2012/03.10.2012 passed by the competent authority which was although barred by limitation as per Rule 10 of HCS (Punishment & Appeal) Rules, 2016, but still he was called for personal hearing on 23.11.2023.

Whereas Rule 10 of Haryana Civil Services (Punishment & Appeal), 2016 provides the time of limitation which is as under:-

Rule 10-Period of Limitation of appeal:-

"No appeal preferred under this rule shall be entertained unless such appeal is preferred within a period of forty-five days from the date on which a copy of the order appealed against is delivered to the applicant.

Provided that the appellate authority may entertain the appeal within next forty five days, if it satisfied that the appellant had sufficient cause for not preferring the appeal in time."

After going through facts and circumstances of the case as well as the submissions made during the personal hearing on 23.11.2023, I have found that neither the delinquent could give any satisfactory explanation for the delay in filing the appeal nor he could provide any fair reason for revoking the above said punishment of stoppage of two increments.

Hence, the appeal filed by Sh. Sh. Rajbir, Clerk (Retd.), O/o DEEO Narnaul is hereby dismissed, being devoid of merits.

Whereas, the petitioner had filed the CWP No. 26016 of 2023 titled as Badama Devi V/s State of Haryana and others before the Hon'ble Punjab and Haryana High Court, praying therein for the issuance of writ in the nature of mandamus directing the respondents to regularize the services of the petitioner w.e.f. 1999/2000 from the date of when the services of the juniors of the petitioner have already been regularized vide order dated 16.09.2002.

The above said writ petition came up for hearing before the Hon'ble High Court on 20.11.2023 and the same was disposed of with the direction to decide the legal notice dated 11.05.2023 of the petitioner. The operative part of the said order is reproduced as under:-

"Without going into the merits of the case, the present petition is disposed of with a direction to respondent No.2-Director, Secondary Education Department, Haryana, to consider and decide the pending legal notice dated 11.05.2023 (Annexure P-5) by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order."

In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 25000/- to the petitioner.

Whereas, in compliance of the above said order passed by the Hon'ble High Court, the legal notice dated 11.05.2023 (Annexure P-5) of the petitioner has been examined and it has been found that the petitioner namely Smt. Badama Devi was engaged as part time class-IV employee against unsanctioned post on 02.09.1985 in the Government Girls Primary School Nanwan, District Mahendergarh. Thereafter, she was regularized on 13.04.2023 in light of the policy dated 11.11.2003 vide order No. 2.210/2023 dated 18.04.2023.

However, it is further clarified here that the examples quoted by the petitioner namely Hanuman Singh, Rohtash Singh, Ami Lal and Krishna Devi were engaged as a part time class IV employee on 07.07.1986, 10.05.1987, 05.05.1987 and 01.02.1990 and their services were regularized on 01.08.1999,01.06.2000, 01.10.2000 and 01.11.2000 in light of the policy dated 30.12.1998/25.02.1999 as per their eligibility in compliance of Hon'ble High Court order dated 24.09.2001 passed in CWP No.5943 of 2000 titled as Rohtash Singh & Others vs. State of Haryana & Others, when the regularization policy dated 30.12.1998/25.02.1999 was in existence.

Whereas, according to previous departmental policy dated 30.12.1998/25.02.1999 the seniority of part time Class-IV employees was at institutional level & as per this policy only those part time Class-IV employees were entitled for regularization of their services against vacant regular sanctioned posts who had requisite experience mentioned in the policy in the institutions where sanctioned post of class-IV were available and the said policy was superseded by new departmental policy dated 11.11.2003.

Whereas, the question of regularization of the services of the petitioners under the New Departmental Policy dated 11.11.2003 is concerned, it is hereby clarified that as per the departmental regularization policy dated 11.11.2003, a common seniority list of all the part time Class-IV employees working in Govt./ Primary/Middle/High/Sr. Secondary Schools and the field offices like O/o BEOs SDOs/ DPEOs/ DEOs/ SCERT/ DIETs/ GETTIS etc. as on 30.06.2003 was prepared by the DEOs concerned at District Level and this seniority list of part time Class-IV employees acts as a reference point for sponsoring the names of the senior most person for regularization against the regular sanctioned post of Class-IV in the field offices/Schools of the Education Department. Therefore, on completion of the tenure of part time service mentioned in the policy dated 11.11.2003, the part

time Class-IV employees are regularized from time to time on the basis of the above said seniority list provided they would fulfill the prescribed qualification for other Class-IV posts.

When, the case of the petitioner was re-examined then it has been found that the petitioner was not entitled for regularization under the prior departmental regularization policy dated 30.12.1998/25.02.1999 as she did not fulfil the main condition of having requisite experience against sanctioned post of Class IV against which she could be regularized. Therefore she was found entitled for regularization w.e.f 14.08.2014 in view of the new departmental regularization policy dated 11.11.2003 as per her eligibility & seniority (i.e.73A) as well as on the availability of vacant sanctioned post. Therefore, her regularization order dated 18.04.2023 has been rectified & hence the petitioner has been regularized vide order No.265/2024 dated 26.01.2024 w.e.f. 14.08.2014(notionally) as per her eligibility. But the petitioner could not be regularized as per the regularization policy dated 30.12.1998/25.02.1999 as she did not fulfill the terms and conditions of that policy. So, the petitioner is entitled to get the benefit as regular employee w.e.f. 14.08.2014 and not prior to that.

Therefore, keeping in view the above mentioned facts and circumstances of the case, the claim of the petitioner for regularization of her service w.e.f 01.08.1999 demanded through legal notice dated 11.05.2023 is not tenable. Hence, the claim of the petitioner demanded through legal notice dated 11.05.2023 is hereby rejected being devoid of merits.
