***".....Learned counsel for the petitioner contends that the issue already stands settled by a judgment dated 13.11.2017, passed by a Single Bench of this Court in CWP No. 25682 of 2014, titled Arun Singh and others v. State of Haryana and another, as clarified by a Division Bench of this Court vide order dated 23.8.2018 in LPA No. 2435 of 2017. The petitioner will be satisfied in case his pending representation-cum-legal notice dated 10.2.2015 (Annexure P-8), is decided by the official respondents, in terms of the law laid down by this Court in the aforesaid judgments and order.***

***Learned State counsel submits that appropriate decision on the representation dated 10.2.2015 will be taken within six weeks from today.***

***In view of the statement made by the learned State counsel, the petition stands disposed of."***

In compliance of above said order, the representation dated 10.02.2015 of Sh. Subhash Chand was duly examined. After examination, it has been found that he had applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') - English against the advertisement no. 1/2012 under Category No. 12.

Whereas, the Directorate of School Education Department had sent a requisition to the Haryana State Teachers Selection Board (now Haryana Staff Selection Commission, Panchkula henereinafter called HSSC) for selection and recommendation of the names of eligible candidates for the post of PGT English. Accordingly, Haryana State Teachers Selection Board advertised the said posts vide Advertisement No. 01/2012 dated 07.06.2012.

Furthermore, it is pertinent to mention here that the whole selection process i.e. from issuing advertisement to the declaration of final result is

carried out by the Haryana State Teachers Selection Board. But, the HSSC has not recommended the name of the petitioner in the recommendation list being an ineligible candidate in pursuance to the advertisement No. 01/2012. So, in absence of recommendation from HSSC, the Department is unable to issue appointment to the petitioner for the post of PGT English.

However, the Hon'ble Court has placed reliance upon the judgment passed in CWP No. 25682 of 2014 titled as Arun Singh & Ors. vs. State Of Haryana & Another, which was disposed of by this Court vide order dated 13.11.2017.

It is further stated that LPA No. 2435 of 2017 was filed against CWP No. 25682 of 2014 and the same was disposed of by the Hon'ble Division Bench vide its order dated 23.08.2018 with the direction to State Government to consider the petitioners for appointment. Now, the matter is pending in Hon'ble Supreme Court in SLP No. 17796 of 2023 titled as the Haryana Staff Selection Commission vs. Parveen Kumari and others before the Apex Court against the said order of Hon'ble Division Bench dated 23.08.2018 & the matter is now *sub-judice* wherein, the stay has already been granted by the Hon'ble Apex Court. The operative part of the order dated 21.08.2023 is re-produced here as under:-

***“Learned Solicitor General submits that the appeal could not have been filed against dropping of the contempt proceedings.***

***Issue notice.***

***In the meantime, further proceedings before the High Court are stayed.”***

Keeping in view of the facts mentioned above & documents on record, the claim raised by Sh. Subhash Chand in his representation dated 10.02.2015 is not tenable and the same is hereby rejected being devoid of merits.

I order accordingly.

Whereas, Sh. Saddik Ahmed had filed Civil Writ Petition No. 24030 of 2023 titled as Saddik Ahmed vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein to direct the respondents no. 1 and 2 to rectify seniority of the petitioner keeping in view his date of joining the service and thereby grant notional/ante-dated promotion to the post of Principal and other consequential benefits attached thereto w.e.f. 20.07.2007, the date when his juniors were given promotion.

The Hon'ble High Court disposed of the said petition vide order dated 11.12.2023 with the following orders:-

***".....In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No.2/Director General, Department of Secondary Education, Haryana, to consider and decide the pending representation dated 11.07.2023, by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order."***

Whereas, in compliance of said order, the representation dated 11.07.2023 of Sh. Saddik Ahmed, PGT History was examined and after examination, it has been found that he was appointed as PGT/Lecturer (History) vide order No. 6/26-91-E-IV(3) dated 18.10.1991.

In 1990, the Department constituted the selection committee for appointment to the post of TGT/PGT of various subjects and the selection committee issued the selection list of various subjects to the post of PGT on 15.10.1991, 18.10.1991, 25.10.1991, 28.10.1991, 13.11.1991, 22.11.1991, 27.11.1991, 06.12.1991 and 13.01.1992.

Whereas, the seniority list as on 08.07.2019 of various subjects was prepared after combining the entire selection list which was issued by the selection committee and finalized as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012. In the present case, Sh. Saddik Ahmed was appointed on 15.10.1991 and the department fixed his seniority No. 221 according to his date of appointment and the seniority of Sh. Saddik Ahmed has already been fixed at appropriate number by the department as per seniority list of July, 2019 was prepared strictly according to the Haryana State Education School Cadre (Group- B) Service Rules, 2012/instructions.


Keeping in view the facts enunciated above and documents on record, the claim of Sh. Saddik Ahmed in the representation dated 11.07.2023

regarding rectification of seniority list of Post Graduate Teachers is not tenable & hereby rejected being devoid of merits.
