Whereas, Sh. Dalip had filed the CWP No. 27113 of 2023 – Dalip Kumar and another Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying therein for directing the respondent-department to fix the salary of the petitioners at par with the other employees who have been selected and appointed in view of Advt. No. 4 of 2015 dated 28.06.2015 for the post of PGT History and further for granting the similar pay scale w.e.f. their entitlement along with all the consequential benefits or financial benefits to the petitioners, in the interest of justice.

The subjected writ petition was listed for hearing on 04.12.2023 and the Hon'ble High Court passed the following orders:-

".....5. In view thereof, without going into the merit of the case, the petition is disposed of with a direction to respondent NO. 2 Director General of Secondary Education, to consider and decide the pending legal notices dated 20.03.2023, by passing a speaking order in accordance with law, within a period of two months from receiving a certified copy of this order.

In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 25,000 to the petitioners."

In compliance of the above said order, the representation dated 20.03.2023 of the petitioners have been examined. It is found that the petitioners have demanded similar pay and other consequential and other financial benefits at par with the other selected candidate of Advt. No. 4 of 2015 dated 28.06.2015 for the post of PGT History.

Whereas, the petitioners were recommended by Haryana Staff Selection Commission against Advt. No. 4/2015 for the post of PGT History. The recommendations of both the petitioners was received by the respondent Department vide recommendation No. HSSC/Confid./Recomn/Court Case/2020/21 dated 04.02.2020 for Sh. Dalip Kumar and recommendation No. HSSC/Confid./Recomn/Court Case/2020/878 dated 01.12.2020 for Sh.



Nadeem Ahmad. Whereas, after completion of appointment proceedings, appointment orders were issued to both the petitioners. Accordingly Sh. Dalip Kumar was allotted GSSS, Sadalpur, Hisar(1472) vide order No. 6/4-2020 PGT1(2) dated 06.07.2020 and Sh. Nadeem Ahmad was allotted GSSS, Garhi Patti, Palwal (1142) vide order No. 6/20-2020 PGT1(2) dated 12.05.2021 and they joined their duties at the post of PGT History.

However, the employees, of whom petitioners have given examples, were recommended vide HSSC/Confid./Recomn/Court Case/2019/331 dated 18.06.2019. Such employees joined at their respective place in the year-2019 prior to the petitioners. In view of this length of service of the petitioners is shorter than the examples, hence the petitioners are not entitled for the notional benefits and only benefit of seniority is to be given to the petitioners.

Hence, claim of the petitioners is liable to be rejected being devoid of merits.
