Whereas, Dr. Majid had filed a CWP No. 16344 of 2023 titled as Dr. Majid vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein to quash the impugned provisional seniority list dated 08.05.2023 w.e.f. 01.01.1996 as on 01.12.2022 qua Mewat Cadre and impugned order dated 22.06.2023 issued by the respondents and stayed the operation of impugned provisional seniority list. Further, direct the respondents to fix the seniority of the petitioner over and above to the respondent No. 3 with all consequential benefits.

The Hon'ble High Court disposed of said writ petition on 28.06.2021 with following orders: -

".....In view thereof, without going into the merits of the case, the petition is disposed of with a direction to the respondent no.2/Director, Department of Secondary Education, Haryana, to consider and decide the pending legal notice dated 20.3.2023 issued by the petitioner, by passing a speaking order thereupon in accordance with law, within a period of six weeks from the date of receiving a certified copy of this order"

In compliance of above said order, the legal notice dated 20.03.2023 of Dr. Majid, PGT Hindi has been duly examined. After examination, it has been found that he was initially appointed as C&V Hindi on 06.10.2000 and later on, promoted to the post of PGT Hindi on 06.05.2016 in Rest of Haryana Cadre.

Whereas, the Department invited the cases of promotion to the post of Principal from the post of PGTs of Mewat Cadre vide letter No. 6/48-2023 HRG-I (2) dated 22.06.2023. The Department received information from District Education Nuh vide dated 17.08.2023 that both the petitioner and respondent No. 3 namely Smt. Geeta Rani were promoted to the post of PGTs in Rest of


111

Haryana Cadre and they were only working in District Mewat as PGTs and not belongs to Mewat Cadre.

Whereas, the Department added these employees of Rest of Haryana Cadre in the Seniority List of Mewat Cadre (Sr. No. 4 to 8) as per the report of DEO Nuh. Now, these employees will be added in the Seniority List of Rest of Haryana Cadre and will be removed from the Seniority List of Mewat Cadre whenever the Department will finalize the seniority list of Mewat Cadre.

In view of the facts mentioned above and perusal of the representation of the petitioner and the documents on record, I have come to the conclusion that the claim of Dr. Majid is not tenable & the same is hereby rejected being devoid of merits.

I order accordingly.
