ORDER No. 13/213-2023 HRME-I (6) Dated, Panchkula, the 11-03-2024

Whereas, the petitioner had filed the Civil Writ Petition No. 27402 of 2023 titled as "Balwan Singh Vs. State of Haryana & Others" before the Hon'ble Punjab and Haryana High Court, praying therein for issuance of a writ in the nature of Mandamus for directing the respondents to regularize the services of the petitioner from the date, juniors to petitioner have been regularized, alongwith all consequential benefits and arrears as per the petitioner has been regularized in the year 2012, whereas, juniors to petitioner have been regularized w.e.f. 01.02.1999/29.10.1999 vide order dated 08.12.2017 (Annexure P-4) and 03.03.2022 (Annexure P-5).

The above said writ petition came up for hearing on **07.12.2023** and the Hon'ble High Court was pleased to dispose of the same with direction to respondent No.2 to decide the legal notice dated 11.05.2022 (Annexure P-6) of the petitioner. The operative part of the said order is reproduced as under:-

"In view thereof, without into the merits of the case, the petition is disposed of with a direction to respondent No. 2-Director, Secondary Education, Panchkula, Haryana, to consider and decide the pending legal notice, dated 11.05.2022, Annexure P-6, by passing a speaking order in accordance with law, within a period of three months from receiving a certified copy of this order. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 25,000 to the petitioner."

In compliance of the above said direction of the Hon'ble High Court, the legal notice dated 11.05.2022 (Annexure P-6) of the petitioner was examined by the department and it has been found that the petitioner was engaged as a part time class IV employee against unsanctioned post of class IV in Govt. Primary School, Ashrafgarh, District Jind on 04.10.1991 and the services of the petitioner were regularized in light of the departmental regularization policy dated 11.11.2003 vide order No. E-2/2012/Appointment/466-670 dated 17.02.2012 and after his regularization he joined in GMS, Ashrafgarh, District Jind. However, the detail of the petitioner is given under in the tabular form:-

Whereas, the contention of the petitioner with regard to regularization in view of policy dated 30.12.1998/25.02.1999 is concerned, in that context, it is pertinent to mention here that earlier the Education Department framed a departmental regularization policy dated 30.12.1998/25.02.1999. But as per the policy dated 30.12.1998/25.02.1999, only those part time class IV were entitled for regularization who had requisite experience mentioned in the policy in the institutions where sanctioned posts of class IV were available because as per this policy the seniority of part time Class IV employees was at institutional level. So, the part time Class IV employees were regularised in the same institution where they were working as part time class IV employees provided the availability of vacant sanctioned post of Class IV. But since the petitioner was working in Govt. Primary School, Ashrafgarh, District Jind as a part time Class IV against unsanctioned post. So, he could not be regularized as per policy dated 30.12.1998/25.02.1999 because he did not fulfil whole terms & conditions of this policy and the said policy was superseded by another departmental Policy dated 11.11.2003 of the Education Department.

Whereas, as per the departmental regularization policy dated 11.11.2003, a common district level common seniority list of all the part time class IV employees working in Govt./Primary/Middle/High/Sr. Secondary Schools and the field offices like O/o BEOs/ SDOs/DPEOs/DEOs/SCERT/DIETs/GETTIs etc. as on 30.06.2003 was prepared by the DEOs concerned at District Level and this seniority list of part time Class-IV employees acts as a reference point for sponsoring the names of the senior most person for regularization against the regular sanctioned post of Class-IV in the field offices/Schools of the Education Department. Accordingly petitioner stands at seniority no.165.

It is pertinent to mention here that, in the light of policy dated 11.11.2003 only those part time Class-IV employees were regularized who were appointed upto 30.06.2003. The petitioner quoted example of Smt. Kelo Devi, Bhateri Devi and Sh. Ishwar Singh such employee who were engaged as a part time class-IV employee in the year 1993 & 1996 but their services were regularized in view of the earlier departmental regularization policy dated 30.12.1998/25.02.1999. But

for

when the cases of quoted examples were re-examined in view of the order dated 19.07.2019 passed in CWP No. 16086 of 2019 titled as Pushpa Devi & Others vs. State of Haryana & Others by the district level committee, headed by DEOS, then it has been found that Smt. Kelo Devi, Smt. Bhateri Devi, Sh. Ishwar Singh whose references were quoted by the petitioner, were engaged as part-time class IV against unsanctioned post in GPS Phullian Khurd (Jind) on 29.10.1993, in GPS Meharara (Jind) on 10.10.1996, GPS Badanpur (Jind) on 02.11.1993 respectively and they were inadvertently regularized on vide Order no. E-2/2012/400-404 order dated 03.02.2012, vide DEO Jind Order no. E-3/2012/Appointment/1343-1352 order dated 07.08.2012 and vide DEO Jind Order no. E-3/2015/731-736 order dated 20.02.2015 in view of the policy dated 30.12.1998/25.02.1999 and in context of that inadvertent regularization, show cause notices were issued to them vide order no.3/2024/472 dated 28.02.2024, vide order no.3/2024/474 dated 28.02.2024, vide order no.3/2024/473 dated 28.02.2024.

Whereas, the petitioner was regularized w.e.f.17.02.2012 vide order no. E-2/2012/Appointment/466-670 dated 17.02.2012 in GMS Ashrafgarh, District Jind in view of the departmental regularization policy dated 11.11.2003 as per his seniority, eligibility as well as the availability of vacant sanctioned post of class IV.

Thus, keeping in view of the position explained above, the claim of the petitioner demanded through Legal Notice dated 11.05.2022 (Annexure P-6) is not tenable and hence rejected being devoid of merits.

Whereas, the petitioner had filed the CWP No. 117 of 2024 titled as Om Prakash Vs State of Haryana & others, before the Hon'ble High Court praying therein for issuance of a writ in the nature of mandamus directing the respondents to consider the representation dated 14.10.2023 (Annexure P-2) and to fix the pension, release the pensionary benefits, amount of gratuity and all the retiral benefits along-with interest @18% per annum after considering whole service period of petitioner i.e. prior to the regularization of service.

The above-said Civil Writ Petition came up for hearing on 08.01.2024 before the Hon'ble High Court & and on that day the Hon'ble High Court was pleased to dispose of the same with directions to respondent No.2 to decide the legal notice dated 14.10.2023 of the petitioner. The operative part of the said order is as follows:-

In view of above, without expressing any opinion on the merits of the case, respondent No.2-Director, Directorate of School Education, Haryana, is directed to decide the legal notice dated 14.10.2023 by passing a speaking order, keeping in view the law laid down in *Kanta Devi vs. State of Haryana & Others*; CWP-5223-20218 passed by this Court on 29.11.2022, within a period of two months from the date of receipt of copy of this order."

In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs.25000 to the petitioner.

In compliance of the aforesaid directions of the Hon'ble High Court, the legal notice dated 14.10.2023 of the petitioner was examined and it has been found that the petitioner was initially engaged as Part-time class IV on 15.11.2002 to the post of Sweeper in Govt. Primary School, Nangal Mohanpur District Mahendergarh against un-sanctioned posts for a short span of 01:30

fu

Hours daily. However, after working for 01:30 Hours daily, the petitioner was free to do any work/job.

Whereas, earlier the Education Department framed its own regularization policy dated 30.12.1998/25.02.1999 which was and thereafter superseded by the new regularization policy of dated 11.11.2003. Further Services of the petitioner were regularized w.e.f. 16.05.2016, as per her seniority and eligibility as and when regular sanction post was available, under the regularization policy of 11.11.2003 (department specific policy), wherein the seniority list of part time class IV employees was made at District level and accordingly the petitioner stands at Seniority Number 727, So, the petitioner is entitled to get the benefit as regular employee w.e.f. 16.05.2016 onwards and not prior to that. The petitioner was regularized vide order no. 41/16 dated 16.05.2016 w.e.f. 16.05.2016 in Government Senior Secondary School, Bewal, District Mahendergarh as per Department regularization policy dated 11.11.2003 as per his seniority, eligibility as well as the availability of vacant sanctioned posts of class IV.

Whereas, as per State Govt. notification dated 18.08.2008, New Pension Scheme came-in-to force, which is applicable to the employees, who have joined as regular employee on or after 01.01.2006 and the petitioner had joined as regular employee on 16.05.2016. Therefore, on the basis of "New Pension Scheme", the PRAN Number was allotted to the petitioner and he had also deposited his share of NPS amount. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable in case of the petitioner.

Moreover, **Rule 3.17 A(g) (iii)** of Punjab Civil Service Rules Volume-II provides that the service rendered by an employee on "PART TIME" basis cannot be computed for pension & pensioner benefits. Relevant portion of the said rule is reproduced as under.

Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

fu

(1) Such service is followed by regular employment.

(2) There is no interruption in the two or more spells of services or the interruptions fall within condonable limits; and

(3) Such services is a whole time employment and not part-time or portion of day.

In view of the above-mentioned facts, the case of the petitioner cannot be considered under Old Pension Scheme as the petitioner was entitled for regularization from 16.05.2016, therefore, he is entitled to get the benefits of New Pension Scheme which was prevalent at the time of regularization of the petitioner and accordingly, the benefits of New Pension Scheme have already been granted/released to the petitioner. Further, for the purpose of getting benefits under the Old Pension Scheme, the employee has to serve as a regular employee within the prevalence of Old Pension Scheme and the same is discontinued from 01.01.2006 onwards and the petitioner was regularized after said date. Therefore, he is not entitled to get the benefits of Old Pension Scheme.

Whereas, judgment dated 29.11.2022 passed by the Hon'ble High Court in CWP No.5223 of 2018 has been stayed by the Hon'ble High Court in LPA No.1119 of 2023 titled as State of Haryana & others vs. Kanta Devi. So, the claim of the petitioner demanded through legal notice dated 14.10.2023 is not tenable and is hereby rejected being devoid of merits.

I order accordingly.

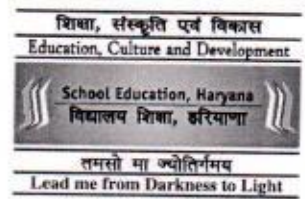

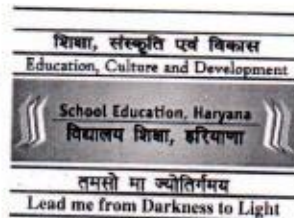
