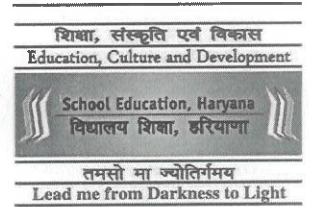

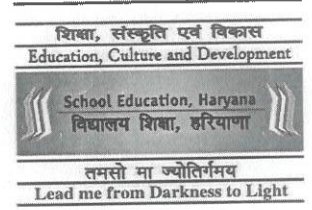

ORDER

Order No. 13/05-2024 PGT-II (6)

Dated, Panchkula, the 11 - 3 - 2024

Whereas, Sh. Virender Kumar (Emp.ID-061417) PGT Hindi GSSS, Kariwala [2829] Block Elanabad, District Sirsa had filed CWP No. 1987 of 2024 titled as Virender Kumar v/s State of Haryana and others with prayer for directing the respondents to transfer the petitioner in District Hisar against vacant posts in various school of PGT (Hindi) in view of the fact that wife of the petitioner is posted in District Hisar and family circumstances of the petitioner, in the interest of justice and equity. Further praying for directing the respondents to decide legal notice dated 08.01.2024 (P-2) and quashing the order dated 31.05.2023 (P-3) qua allotment of station to the petitioner.

The abovementioned civil writ petition came up for hearing on 31.01.2024, and on that day, the Hon'ble High Court was pleased to dispose of the same with direction to respondents to consider and decide the pending legal notice dated 08.1.2024. The operative part of the order dated 31.01.2024 is as under:-

"...In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No.2/Director Secondary Education, Haryana, to consider and decide the pending legal notice dated 08.01.2024, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving a certified copy of this order.

6. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹25,000 to the petitioner."

Whereas, the Government of Haryana framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction.



amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him in the State. She/He is free to give preferences in order of their suitability. For the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station, on the other hand following categories of teachers have been asked to participate in the transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in the present zone of posting, shall be taken as a deemed vacancy and such teacher shall participate compulsorily in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also participate compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of administrative or Promotion cases or litigation nature.


In compliance of the Hon'ble High Court Order dated 31.01.2024, legal notice of the petitioner namely Sh. Virender Kumar (Emp.ID-061417) PGT Hindi dated 08.01.2024 (P-2) was examined by the department and it was found that initially the petitioner was posted as Trained Graduate Teacher (TGT) Hindi in Government High School, Sheikhpura (Hissar)[1317]. Thereafter, the petitioner was promoted as Post Graduate Teacher (PGT) Hindi vide order dated 31.05.2023. Thereafter, the online options were invited from all promotees for allotment of temporary station. The petitioner had also filled up 21

preferences and all of the preferences filled by him were allotted to participants who were higher in merit and hence, he got station under anywhere category. So, the petitioner was temporarily adjusted in Government Senior Secondary School Kariwala (2829), Block Elanabad, Sirsa vide order no. 15/19-2022 PGT-I(3) dated 31.05.2023 on promotion as PGT Hindi, subject to the condition that he/she is posted temporarily in the school with condition that he/she must participate in the next phase of transfer drive for permanent posting.

Whereas, further the petitioner contended that inspite of lapse of more than seven months process of transfer drive has not been initiated by the department and as per policy (amended on 09.08.2023), he is entitled to get 5 marks of couple case. In this regard, it is germane to mention here that the as per Teacher Transfer Policy, 2016 only females are allowed to get benefit of five marks of couple case. It is also pertinent to mention here that Teacher Transfer Policy, 2016 has been substituted by the Teacher Transfer Policy, 2023. As per the new policy all male and female teachers of couple case working in regular capacity are entitled to get benefit of five marks. In this year, General Transfer drive has been kept on hold due to some administrative reasons/ exigencies of the department and whenever, transfer drive is started, the case of the petitioner will be considered accordingly.

Whereas, it is further clarified here that the petitioner service is governed under the Haryana State Education School Cadre (Group-B) Service Rules, 2012. According to the rules, the employee is liable to serve at any place within or outside Haryana. The rule 12 (1) of the 2012 rules is reproduced here under:-

"A member of the service shall be liable to serve at any place, whether within or outside the State of Haryana on being ordered so to do by the appointing authority."



Whereas, it is also submitted here that, a government employee (i.e. petitioner) or any servant of a Public Service has no legal right to insist to be posted at any particular place and the same has also been upheld by the Hon'ble Apex Court on 06.09.2021 in SLP No. 36717 of 2017 in CWA no. 48447 of 2017 in which the Hon'ble Apex Court has held that "***it is not for the employee to insist to transfer him/her and/or not to transfer him/ her at a particular place. It is for the employer to transfer an employee considering the employment.***" It cannot be disputed that the petitioner holds a transferable post and unless specifically provided in his service conditions, he has no choice in the matter of posting. Since the petitioner has no legal or statutory right to claim his posting at a place of his choice, his claim is not maintainable.

In view of the facts mentioned above, the claim of the petitioner as prayed in the petition as well as legal notice dated 08.01.2024 is not tenable as the temporary posting of the petitioner has been done as per reasons cited *supra*. Therefore, there is no merit in claim of the petitioner and the same is liable to be rejected.

I order accordingly.
