उपरोक्त रिट याचिका माननीय उच्च न्यायालय के समक्ष सुनवाई के हेतु दिनांक 15.11.2022 को लगी हुई थी जिसमें माननीय न्यायालय द्वारा निम्नलिखित निर्देशों के साथ इसका निपटारा किया गया:-

“याचिकाकर्ता के वकील का कहना है कि इस स्तर पर, वह संतुष्ट होंगे यदि वर्तमान याचिकाकर्ता की ओर से दिए गए कानूनी नोटिस दिनांक 04.01.2022 (अनुलग्नक पी-16) पर निर्णय लेने के लिए प्रतिवादी नंबर 2 को निर्देश के साथ रिट याचिका का निपटारा किया जाता है।

मुझे याचिकाकर्ता के विद्वान वकील द्वारा की गई प्रार्थना उचित लगती है।

तदनुसार, इस स्तर पर, मामले की योग्यता पर टिप्पणी किए बिना, प्रतिवादी नंबर 2 की ओर से दिए गए कानूनी नोटिस दिनांक 04.01.2022 (अनुलग्नक पी-16) पर निर्णय लेने के निर्देश के साथ रिट याचिका का निपटारा किया जाता है। याचिकाकर्ता को, स्पीकिंग ऑर्डर पारित करके और याचिकाकर्ता को सुनवाई का अवसर प्रदान करने के बाद, अधिमानतः इस आदेश की प्रमाणित प्रति प्राप्त होने की तारीख से दो महीने के भीतर।

माननीय उच्च न्यायालय के उपरोक्त आदेश के अनुपालना में याचिकाकर्ता के कानूनी नोटिस दिनांक 04.01.2022 की सूक्ष्मता से जांच की गई और पाया गया कि याचिकाकर्ता के पति श्री जसमेर सिंह पुत्र स्व0 माम चंद द्वारा दिनांक 10.05.1995 को जिला कुरुक्षेत्र में अंशकालिक चतुर्थ श्रेणी के कर्मचारी के रूप में गैर स्वीकृत पद पर शिक्षा विभाग में कार्यभार ग्रहण किया तथा आदेश संख्या ई-3/2019/2721-62 दिनांक 09.07.2019 को विभागीय नियमितकरण नीति दिनांक 11.11.2003 के तहत उन्हें दिनांक 01.04.2011 नियमित किया गया और यह विभागीय नीति CWP No. 5926/2001 शीर्षक विद्या देवी एवं अन्य बनाम हरियाणा सरकार व अन्य में माननीय उच्च न्यायालय के निर्देश दिनांक 20.02.2002 की अनुपालना में विभाग द्वारा बनाई गई थी। इस प्रकार दिनांक 11.11.2003 की नीति के अनुसार वरिष्ठता सूची जिला स्तर पर तैयार की गई थी और तदनुसार याचिकाकर्ता के पति वरिष्ठता संख्या 296 पर थे। इसलिए वरिष्ठता सूची के आधार पर उनके पति को भी आदेश क्रमांक ई-3/2019/2721-62 दिनांक 09.07.2019 के तहत तब से नियमित किया गया था जब नियमित रिक्त चतुर्थ श्रेणी में स्वीकृत पद उपलब्ध हुए।

उपरोक्त तथ्यों को ध्यान में रखते हुए कानूनी नोटिस दिनांक 04.01.2022 के माध्यम से याचिकाकर्ता द्वारा किया गया दावा मान्य नहीं है इसलिए उसको खारिज किया जाता है।
