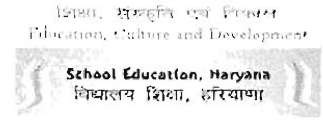

**Terms and conditions:-**

If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. Pinki Kumari [1006869] has filed CWP No. 26015 of 2023 titled as Pinki Kumari vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to grant the benefit of promotion to the post of PGT English w.e.f. 08.01.2021 the date on which the junior TGT teachers were promoted.

The Hon'ble Punjab & Haryana High Court disposed of the said petition on dated 20.11.2021 with following orders:

*".....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no. 3 - Director Secondary Education, to decide the pending representation of the petitioner, dated 16.08.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to the effect will be passed within four weeks thereafter.*

*In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 25,000 to the petitioner."*

Whereas, in compliance of the above said order, the representation dated 16.08.2023 of the petitioner is duly examined and it is found that she was initially appointed as PRT/JBT on 15.09.2008 and later on, promoted to the post of TGT English on 30.08.2018.

Whereas, as per Haryana State Education School Cadre (Group B) Service Rules, 2012, the qualification for promotion of PGT English (Post Graduate Teacher) from TGT English (Trained Graduate Teacher) is as under:-

**By promotion:-**

- (i) **M.A. English with at least 50% marks and B.Ed. from recognized university; AND**
- (ii) **2 years teaching experience as TGT English; or Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation**

It is clear from the above rules that the candidate to be promoted as PGT English, must have M.A. English from recognized university. Smt. Pinki Kumari joined as TGT English on 30.08.2018 and she acquired the qualification of M.A. on 28.08.2021. The cutoff date for applying for the

On that day, petitioner did not have requisite qualification as required under Haryana State Education School Cadre (Group-B) Service Rules, 2012, hence, she was found not eligible for promotion to the post of PGT (English) whereas those who were promoted to the post of PGT on 08.01.2021, have the requisite experience and qualifications as per the Haryana State Education School Cadre (Group-B) Service Rules, 2012 on the relevant date.

In view of the facts mentioned above, the claim of Smt. PinkiKumari is not tenable & hereby rejected being devoid of merits.
