Dinesh Monga has filed CWP No. 21108 of 2023 titled as Dinesh Monga vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to grant promotion to the petitioner to the post of PGT Hindi w.e.f. 06.05.2016 i.e. the date juniors to the petitioner were promoted and to grant all consequential benefits to the petitioner from 06.05.2016.

The Hon'ble High Court was pleased to dispose of the said petition on dated 21.09.2023 with following orders:-

*“.....In view thereof, without going into the merits of the case, the petition is disposed of with a direction to respondent no.2/Director General, Secondary Education, Haryana, to consider and decide the pending legal notice, dated 5.7.2023, issued by the petitioner, by passing a speaking order thereupon in accordance with law, within a period of eight weeks from the date of receiving a certified copy of this order.”*

In compliance of above said order, the legal notice dated 05.07.2023 of Sh. Dinesh Monga, TGT Hindi has been duly examined. After examination, it has been found that he was initially appointed as C&V Hindi on 28.03.2010 and joined to the post of C&V Hindi on 01.04.2010.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for recruitment by promotion of Hindi PGT (Post Graduate Teacher) is as under:-

<b>Designation of Posts</b>	<b>Academic qualification and experience, if any, for appointment other than by direct recruitment on contract basis</b>
<b>PGT Hindi</b>	<p style="text-align: center;"><b>By promotion:-</b></p> <p>(i) M.A. Hindi with atleast 50%marks and B.Ed from recognised university; AND</p> <p>(ii) 2 years teaching experience as TGT Hindi/ Hindi teacher.</p>

Whereas, it is apparent from above quoted rules that B.Ed from recognised university is required for promotion to the post of PGT Hindi. The petitioner namely Sh. Dinesh Monga possessed the qualification of Shiksha Shastri. So, the petitioner does not possess the requisite qualification for promotion to the post of PGT Hindi.

Whereas, juniors of the petitioner possessed the requisite qualification i.e. B. Ed from recognized University, so, they were promoted to the post of PGT Hindi as per rules.

On the day of promotion, petitioner did not possess the master degree i.e. M.A English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 and 13.04.2022 reason being that they possess the requisite qualification for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Karamvir Singh is not tenable & hereby rejected being devoid of merits.


