Notification

The 22nd September, 1995

No. G.S.R. 76/Constitution/Article 309/95.—In exercise of the power conferred by the proviso to article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following rules:—Further to amend the Haryana Education Department (State Service, Group B) Service Rules, 1980, namely:—

1. These rules may be called the Haryana Education Department (State Service, Group B) First Amendment Rules, 1995.
2. In the Haryana Education Department (State Service, Group B) Rules, 1980 (hereinafter called the said rules), in rule 9, in sub-rule (1),—
 - (a) In clause (a), in sub-clause (i), the words "Assistant Registrar (Examinations)" shall be omitted;
 - (b) Clause (b) shall be omitted; and
 - (c) after clause 'd', the following shall be inserted, namely:—
 - ((c) in the case of Research Officer (Statistics),
(i) by promotion from amongst the Assistant Research Officer (Statistics) in the Haryana Education Department (State Service Group-C) Service; or
 - (ii) by transfer or deputation of an officer already in the service of Government of India or any state Government; or
 - (iii) by direct recruitment."
3. In the said rules, in rule 14, in sub-rules (1) and (2), for the words, signs and figures "Punjab Civil Services (Punishment and appeals) Rules, 1952", the words, signs and figures, "Haryana Civil Services (Punishment and Appeal) Rules, 1987" shall be substituted.
4. In the said rules, for Appendix A, the following Appendix shall be substituted, namely:—
