Whereas, Sh. Dinesh Monga has filed CWP No. 21108 of 2023 titled as Dinesh Monga vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to grant promotion to the petitioner to the post of PGT Hindi w.e.f. 06.05.2016 i.e. the date juniors to the petitioner were promoted and to grant all consequential benefits to the petitioner from 06.05.2016.

The Hon'ble High Court was pleased to dispose of the said petition on dated 21.09.2023 with following orders:-

***".....In view thereof, without going into the merits of the case, the petition is disposed of with a direction to respondent no.2/Director General, Secondary Education, Haryana, to consider and decide the pending legal notice, dated 5.7.2023, issued by the petitioner, by passing a speaking order thereupon in accordance with law, within a period of eight weeks from the date of receiving a certified copy of this order."***

In compliance of above said order, the legal notice dated 05.07.2023 of Sh. Dinesh Monga, TGT Hindi has been duly examined. After examination, it has been found that he was initially appointed as C&V Hindi on 28.03.2010 and joined to the post of C&V Hindi on 01.04.2010.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for recruitment by promotion of Hindi PGT (Post Graduate Teacher) is as under:-

Whereas, it is apparent from above quoted rules that B.Ed from recognised university is required for promotion to the post of PGT Hindi. The petitioner namely Sh. Dinesh Monga possessed the qualification of Shiksha Shastri. So, the petitioner does not possess the requisite qualification for promotion to the post of PGT Hindi.

Whereas, juniors of the petitioner possessed the requisite qualification i.e. B. Ed from recognized University, so, they were promoted to the post of PGT Hindi as per rules.

Keeping in view the facts enunciated above and documents on record, the claim of Sh. Dinesh Monga is not tenable and hereby rejected being devoid of merits.

**ORDER No. 13/8-2024 HRME-I (4)**

**DATED, Panchkula, the 22/03/2024**

Whereas, the petitioners had filed the Civil Writ Petition No.29266 of 2023 titled as Gagan Khanna & Others vs. State of Haryana & Others, before the Hon'ble High Court praying therein for issuance of a writ in the nature of certiorari for setting aside the impugned speaking order of transfer date 14.08.2020 (P-4) qua petitioners and speaking order dated 25.05.2023 (Annexure P-11) and order dated 13.06.2023/20.06.2023 (Annexure P-13) and order dated 05.12.2023/11.12.2023 (P-17) qua petitioners only wherein the relief claimed in representation dated 16.12.2022 (Annexure P-9 to P/B) & 02.06.2023 (P-12) has been declined.

The above said Civil Writ Petition came up for the adjudication before the Hon'ble Court on 15.01.2024 and the same was disposed of with directions to decide the representations of the petitioners. The operative part of the aforesaid orders is reproduced here as under:-

**In view thereof, the petition is dismissed as withdrawn of with liberty to the petitioners to file a representation before respondent No.2 within a period of one week from today. In case any such representation is filed, the same shall decide by respondent No.2/Director Secondary Education, Haryana, by passing a speaking order in accordance with law keeping in view the office order dated 13.06.2023, within a period of four weeks from the date of receiving the representation.**

Whereas, in compliance of above said order, the representation dated 22.01.2024 of the petitioners was examined and it has been found that the petitioners have earlier filed the CWP No.19824 of 2020 titled as Vikas & Others vs. State of Haryana & Others and the same was disposed of by the Hon'ble High Court on 12.12.2022 in terms of order passed in CWP No.13810 of 2021(O&M), titled as Mohit and others Vs. State of Haryana and others,

decided on 12.07.2022. The operative part of the order dated 12.07.2022 is as under:-

*Keeping in view the above, the present petitions are disposed of in the agreed terms that the petitioners will file representation within a period of 7 days from today i.e. upto 18th of July, 2022 giving their options for transfer to the posts which are still lying vacant. The State is directed to decide the said representations in accordance with law coupled with the provisions of the policy with a sympathetic consideration so as to avoid any further litigation and to streamline the functioning of the schools concerned, within a period of 4 weeks thereafter. It is made clear that till the decision of the representation, the petitioners will be allowed to serve at the places where they are actually working now and in case, their representation is accepted and they are posted in a school which they have opted in the representation, they will join the same, otherwise, the petitioners will join schools where they have already been transferred by the respondents in the orders impugned in their petitions, which fact would be made clear by the respondents while deciding their representation. It is also made clear that a particular petitioner cannot opt for more than three schools in his representation and in case, any of the petitioners opt for the same posting, the length of the service should be taken into consideration while deciding their claim with regard to the option. Civil miscellaneous applications No.CM-2758-CWP-2022 and CM-11671-CWP-2021 in CWP No.13810 of 2021, CM-13046-CWP-2021 in CWP-9163-2021, CM-16284-CWP-2021 in CWP-15468-2021 and CM-5074-CWP-2022 in CWP-11116-2021 also stand disposed of.*

In view of the above said order of the Hon'ble High Court, an opportunity to all the petitioners of the above said writ petitions was granted by the Department to opt three stations of their choices and suitability which were lying vacant. All the petitioners opted the stations according to their suitability and choice. Accordingly, 97 petitioners out of 133 petitioners have been adjusted at the stations/schools which were opted by them. 25 petitioners out of the said 97 petitioners, were given the vacant stations out of their said three preferences and hence adjusted them against vacant posts and remaining 72 petitioners have been adjusted against other employees/clerks who joined after the decision

of the Hon'ble High Court on 12.07.2022. Thus, transfer of the petitioners has been done in a fair & transparent manner in strict compliance of the Hon'ble High Court.

Further, it is relevant to clarify here that petitioners could not get stations out of their three opted preferences due to non-availability of the said stations because some of those stations had already been allotted to other employees before passing of order dated 12.07.2022 of the Hon'ble High Court, whereas some stations were not offered (being kept) at the time of transfer drive, 2020 and some stations have been allocated to other employees whose length of services was more than the petitioners as per the direction of the Hon'ble High Court. The detailed particulars of the petitioners has been explained below:-

Whereas after passing of speaking order dated 25.05.2023, the petitioners of present writ petition challenged the said speaking order by way of

filing writ petition No.15926 of 2023 titled as Ajay Kumar & Others vs. State of Haryana & Others in the Hon'ble High Court and same was disposed of on 11.09.2023 with directions to decide the representations of the petitioners and in compliance of the Hon'ble Court order dated 11.09.2023, the well-reasoned speaking order vide order no.13/132-2023 HRME-1(4) dated 05.12.2023 was passed by the department. Thereafter the petitioners of CWP No. 15926 of 2023 filed present writ petition to challenge the order dated 25.05.2023 as well as 05.12.2023.

Whereas, in context of order dated 13.06.2023, it is hereby clarified that by this said order only those new appointees were adjusted at whose place of posting other employees were adjusted in compliance of Hon'ble High Court Order dated 12.07.2022 because those stations had been allotted to the new appointees before the decision dated 12.07.2022 of the Hon'ble High Court.

In this way, strict compliance of the order dated 12.07.2022 of the Hon'ble High Court had already made and the claim of the petitioners demanded through the representation dated 22.01.2024 is not tenable as the petitioners had been transferred in strict compliance of the transfer policy dated 06.03.2020, which has a chain reaction and if any shuffling is done that will create chaos all over Haryana as the same has State vide ramification and hence the claim of the petitioner demanded through the representation is hereby rejected being devoid of merits.
