Whereas, Sh. Rajesh filed CWP No. 927 of 2024 titled as Rajesh vs. State of Haryana & others praying therein to direct the respondent department to promote the petitioner to the post of PGT English w.e.f. 13.04.2022, the date from which junior TGT teachers were given promotion with all the consequential benefits.

The Hon'ble High Court was pleased to dispose of the said writ petition vide order dated 16.01.2024 with following orders/direction:-

“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, dated 19.04.2022, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”

In compliance of the above said order, the representation dated 19.04.2022 of Sh. Rajesh, TGT English has been duly examined and it is found that he was initially appointed as PRT/JBT on 05.10.2000 and later on, promoted to the post of TGT/Master (English) on 27.12.2019 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualifications for promotion to the post of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) are as under:-

By promotion:-

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT English; or
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

It is clear from above mentioned qualifications that a teacher for promotion as PGT English, must have two years experience of TGT English as well as M.A. in English.

Whereas, Sh. Rajesh joined as TGT English on 30.12.2019. The cut off date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021. Thereafter, again promotion cases were invited and cut off date for applying for

ju

the promotion by sending the cases through proper channel was 30.11.2021 and promotion orders were issued on 13.04.2022. The meeting of Departmental Promotion Committee for scrutiny of promotion cases was held on 12.01.2022. This meeting was held within approximately 2 months of cut off date, hence there is no delay on behalf of the Department. On the cut off date i.e. 30.11.2021, petitioner did not possess the requisite qualification as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 and 13.04.2022 reason being that they possess the requisite qualification for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) on the date of promotion.

In view of the facts mentioned above, the claim of Sh. Rajesh is not tenable & the same is hereby rejected being devoid of merits.

I order accordingly.

Whereas, Sh. Sumit Kumar has filed CWP No. 5577 of 2024 titled as Sumit Kumar vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to promote the petitioner to the post of PGT English w.e.f. 13.04.2022 i.e. the date from which his juniors have been promoted, with all consequential benefits including seniority & fixation of pay.

The Hon'ble Punjab & Haryana High Court disposed of the said petition on dated 11.03.2024 with following orders:-

".....Learned State counsel accepts notice and submits that the pending representation will be decided by the second respondent/Director General, Department of Secondary Education, Haryana, within a period of two months from the date of receiving a certified copy of this order.

In view of the statement made by learned State counsel, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.

Ordered accordingly."

In compliance of above said order, the representation dated 19.01.2024 of Sh. Sumit Kumar, TGT English has been duly examined and it is found that he was initially appointed as PRT/JBT on 20.12.2004 and later on, promoted to the post of TGT English on 04.03.2022 w.e.f. 17.07.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualifications for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) are as under:-

By promotion:-

(i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND

(ii) 2 years teaching experience as TGT English; or

Two years' experience of teaching as TGT English in case of TGT Social Studies having TGT English as an Elective subject in Graduation.

It is clear from above mentioned qualifications that a teacher for promotion as PGT English, must have two years experience of TGT English as well as M.A in English.

Whereas, Sh. Sumit Kumar acquired the qualification of M.A. English in June-2021. The cut off date for applying for the promotion by sending the cases

through proper channel was 30.11.2021 and promotion orders were issued on 13.04.2022. The meeting of Departmental Promotion Committee for scrutiny of promotion cases was held on 12.01.2022. On the day of consideration, petitioner did not possess two years experience as TGT English because petitioner joined as TGT on 08.03.2022, therefore as per Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) petitioner does not found to be eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 13.04.2022 reason being that they possess the requisite qualifications for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended).

In view of the facts mentioned above, the claim of Sh. Sumit Kumar is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.

SPEAKING ORDER**

No. 13/66-2024 PGT-I (1)

Dated, Panchkula, the 23.04.2024

Whereas, Smt. Anuma Yadav has filed CWP No. 4563 of 2024 titled as Anuma Yadav vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent department to promote the petitioner to the post of PGT Political Science w.e.f. 13.04.2022, the date of the junior TGT teacher whom have been given promotion with all the consequential benefits.

The Hon'ble Punjab & Haryana High Court disposed of the said petition on dated 28.02.2024 with following orders:-

“...In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no. 2 - Director, Secondary Education, to decide the pending representation of the petitioner, dated 07.09.2023, by passing a speaking order in accordance with law, within a period of six weeks from receiving a certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”

In compliance of above said order, the representation dated 07.09.2023 of Smt. Anuma Yadav, TGT Social Studies has been duly examined and it is found that she was initially appointed as TGT Social Studies on 13.12.2004.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualifications for promotion of Political Science PGT (Post Graduate Teacher) from Social Studies TGT (Trained Graduate Teacher) are as under:-

By promotion:-

- (i) M.A. Political Science with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT Social Studies; or


Whereas, Smt. Anuma Yadav joined as TGT Social Studies on 16.12.2004 and she acquired the qualification of M.A. Political Science on 03.12.2021. The cut off date for applying for the promotion by sending the cases through proper channel was 31.11.2021 and promotion orders were issued on 13.04.2022. The meeting of Departmental Promotion Committee for scrutiny of promotion cases was held on 12.01.2022. The meeting was held within 2 months from cut off date, so there is no delay on behalf of the department. On the day of fixed as cut off date, petitioner did not possess the

ju

master degree i.e. M.A Political Science as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended) and hence, found not eligible for promotion to the post of PGT (Political Science). Juniors of the petitioner were promoted to the post of PGTs on 13.04.2022 reason being that they possess the requisite qualification for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012, on the date of promotion.

In view of the facts mentioned above, the claim of Smt. Anuma Yadav is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.




