

Whereas, Sh. Rampal Singh had filed the CWP No. 29550 of 2022 titled as Rampal Singh Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying therein to direct the respondents to appoint the petitioner on the post of Post Graduate Teachers (Math) against the advertisement No. 1/2012 dated 07.06.2012 in terms of the judgment dated 27.05.2015 passed in CWP No. 7626 of 2015 titled as Gurmail Kaur and others vs. State of Haryana and others.

The above mentioned writ petition came up for adjudication on 21.12.2022 and the Hon'ble Court disposed of the same vide order dated 21.12.2022. The operative part of the same is as under: -

"...In view of the pleadings in the present petition, without expressing any opinion on the merits of the case or the claim being made by the petitioner in the representation, respondent No. 2 is directed to decide the representation dated 07.08.2022 (Annexure P-12), by passing a speaking order within a period of eight weeks from the receipt of copy of this order.

Present writ petition stands disposed of."

In compliance of the above said order dated 21.12.2022 passed by the Hon'ble High Court, the representation dated 07.08.2022 has been examined and thereupon, it has been found that the candidature of the petitioner was not considered by the Department on the ground that the petitioner has obtained the requisite qualification from the deemed to be university i.e. Institute of Advanced Studies In Education University, Sardarshahar, Rajasthan.

Whereas, it has been specifically mentioned in Rule No. 2 (h) of the 2012 Rules that only the recognized universities were to be considered for the purpose of appointment/promotion to the post of PGT. The relevant portion of the Rule is reproduced here as under:-



2 (h) Recognized University

- (i) **any university incorporated by Law in India; or**
- (ii) **any other university which is declared by the Government to be a recognized university for the purpose of these rules;**

Whereas Institute of Advanced Studies in Education University, Sardarshahar, Rajasthan is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Govt. and UGC. Whereas this University did not take permission from the State Government and UGC before opening study center to run distance education programme. In absence of the permission of UGC and State Government wherein study centers are located, the degrees obtained from such study centers by the candidates are not legal and such candidates are not eligible for appointment/promotion as PGT in Haryana Govt. Services.

Whereas, similar candidates seeking appointment had earlier filed a CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court allowed the writ petition vide order dated 27.05.2015.

Now the matter is pending in the Hon'ble Supreme Court in SLP No.017134/2021 titled as State of Haryana and others vs. Gurmail Kaur and others, which is fixed for ~~22.10.2024~~ (tentative).

Whereas, same other similarly situated candidates pertaining to appointment have filed CWP No. 22528 of 2021, which was allowed by Hon'ble High Court on 29.08.2022. Thereafter, the department has filed the Latent Patent Appeal No. 98 of 2023 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 29.08.2022 & the matter is now subjudice wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the stay order is re-produced here as under:-

“.....Granting time to the respondent to file reply to the stay application, this Court in the meanwhile, by way an ad-interim measure,



stay operation of the impugned judgment passed by the learned Single Judge.”

Whereas, at this stage the issue w.r.t. deemed universities is *sub-judice* before the Hon'ble Apex Court as well as before the Hon'ble High Court and there is an interim order passed by the Hon'ble High Court dated 02.02.2023 as referred *supra*. Whereas, Smt. Harpreet Kaur had filed the CWP No. 29541 of 2022 titled as Harpreet Kaur Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying therein to direct the respondents to appoint the petitioner on the post of Post Graduate Teachers (Math) on account of her selection in the selection list/result dated 12.01.2019 issued by the Haryana Staff Selection Commission against the advertisement No. 4/2015 dated 28.06.2015 in terms of the judgment dated 27.05.2015 passed in CWP No. 7626 of 2015 titled as Gurmail Kaur and others vs. State of Haryana and others and judgment dated 29.08.2022 passed in CWP No. 22528 of 2021 titled as Vikas Kumar vs. State of Haryana and others.

The above mentioned writ petition came up for adjudication on 21.12.2022 and the Hon'ble Court disposed of the same vide order dated 21.12.2022. The operative part of the same is as under: -

"....In view of the pleadings in the present petition, without expressing any opinion on the merits of the case or the claim being made by the petitioner in the demand notice, respondent No. 2 is directed to decide the demand notice dated 27.11.2022 (Annexure P-9), by passing a speaking order within a period of eight weeks from the receipt of copy of this order.

Present writ petition stands disposed of."

In compliance of the above said order dated 21.12.2022 passed by the Hon'ble High Court, the demand notice dated 27.11.2022 has been examined and thereupon, it has been found that the candidature of the petitioner was not considered by the Department on the ground that the petitioner has obtained the requisite qualification from the deemed to be university i.e. Institute of Advanced Studies In Education University, Sardarshahar, Rajasthan.

Whereas, it has been specifically mentioned in Rule No. 2 (h) of the 2012 Rules that only the recognized universities were considered for the purpose of appointment/promotion to the post of PGT. The relevant portion of the Rule is reproduced here as under:-

ju

2 (h) Recognized University

- (i) **any university incorporated by Law in India; or**
- (ii) **any other university which is declared by the Government to be a recognized university for the purpose of these rules;**

Whereas Institute of Advanced Studies in Education University, Sardarshahar, Rajasthan is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Govt. and UGC. Whereas this University did not take permission from the State Government and UGC before opening study center to run distance education programme. In absence of the permission of UGC and State Government wherein study centers are located, the degrees obtained from such study centers by the candidates are not legal and such candidates are not eligible for appointment/promotion as PGT in Haryana Govt. Services.

Whereas, similar candidates seeking appointment had earlier filed a CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court allowed the writ petition vide order dated 27.05.2015.

Now, the matter is pending in the Hon'ble Supreme Court in SLP No.017134/2021 titled as State of Haryana and others vs. Gurmail Kaur and others. Which is fixed for 22.10.2024 (tentative).

Whereas, other similarly situated candidates pertaining to appointment have filed CWP No. 22528 of 2021, which was allowed by Hon'ble High Court on 29.08.2022. Thereafter, the department filed the Latent Patent Appeal No. 98 of 2023 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 29.08.2022 & the matter is now subjudice wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the stay order dated 02.02.2023 is re-produced here as under:-

“.....Granting time to the respondent to file reply to the stay application, this Court in the meanwhile, by way an ad-interim measure, stay operation of the impugned judgment passed by the learned Single Judge.”


Whereas, at this stage the issue w.r.t. deemed universities is *sub-judice* before the Hon'ble Apex Court as well as before the Hon'ble High Court and there is an interim order passed by the Hon'ble High Court dated 02.02.2023 as referred *supra*. Therefore, at this stage the

department is in-capacious to proceed with the claim of the petitioner demanded through re-presentation dated 27.11.2022.

Keeping in view of the facts mentioned above & documents on record and orders of Hon'ble Division Bench, the claim raised by Smt. Harpreet Kaur in his representation dated 27.11.2022 is not tenable at this stage & hereby rejected being devoid of merits.

I order accordingly.
