Whereas, Smt. Deep Mala has filed CWP No. 25720 of 2023 titled as Deep Mala vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent-Department to promote the petitioners to the post of Post Graduate Teacher (PGT) English w.e.f. 08.01.2021, the date of promotion of the junior TGTs with all the consequential benefits.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 16.11.2023 with following orders:-

*“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing respondent no.3 to decide the pending representation of the petitioner, Annexure P-4, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.”*

In compliance of above said order, the representation dated 26.07.2023 of Smt. Deep Mala, TGT English has been duly examined and it is found that she was initially appointed as PRT/JBT on 15.09.2008 and later on, promoted to the post of TGT/Master (English) on 28.08.2018.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

**By promotion:-**

(i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND

(ii) 2 years teaching experience as TGT English; or

Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Smt. Deep Mala joined as TGT English on 29.08.2018 and she has acquired the qualification of M.A. on 10.01.2022. The cut off date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021. Thereafter, again promotion cases were invited and cut off date for applying for the promotion by sending the cases through proper channel was 30.11.2021 and promotion

ju



orders were issued on 13.04.2022. The meeting of Departmental Promotion Committee for scrutiny of promotion cases was held on 12.01.2022. The meeting was held within 2 months from cut off date, so there is no delay on behalf of the department. On the day of DPC, petitioner did not possess the master degree i.e. M.A English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 and hence, found not eligible for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs on 08.01.2021 and 13.04.2022 reason being that they possess the requisite qualifications for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012.

In view of the facts mentioned above, the claim of Smt. Deep Mala is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.
