Dear

The above mentioned writ petition seeking writ of mandamus directing the official-respondents to give joining to the petitioner alongwith notional benefit for the post of Steno-Typist (Both Language) under the EBPG category was listed for hearing before Hon'ble Mr. Justice H.S.Sethi on 2nd May, 2024. The petitioner has relied upon various orders passed by the Hon'ble High Court which have been annexed as Annexures P-19 to P-22 and P-24 to P-26 passed in case of similarly EPBG Category situated employees. The Hon'ble Court has disposed of the writ petition vide order dated 2nd May, 2024 on the statement made on behalf of the State that the representation received in Office of the concerned authority will be decided by the concerned authority within a period of four weeks and after decision of the representation, any benefit accruing to the petitioner will also be released.

Similar writ petitions are coming up for hearing on day to day basis before the Court whereby the candidates recommended by the Commission are seeking direction to the respondent-State to give them joining on the advertisement. You are requested to decide the claim of the similarly situated employees on parity to avoid unnecessarily filing of the writ petitions in the Hon'ble High Court.
