

Whereas, Mukesh Sharma and another have filed a CWP No. 3282 of 2024 titled as Mukesh Sharma & another Vs State of Haryana and others, for issuance of a writ in the nature of mandamus for directing the respondents to count the service rendered by petitioners in respondent no.3 i.e. Government Aided School prior to their Joining the respondent department as qualifying service for the purpose of calculating total service for grant of pensionary benefits in view of the law laid down by this Hon'ble Court in case titled as "Smt Usha Rani Thakral Vs. State of Haryana & Ors" reported as 2019 (2) SCT 609 (Annexure P-14) along with interest at the rate of 9% per annum.

That the aforesaid writ petition came up for hearing on 14.02.2024, and on that day the Hon'ble High Court was pleased to dispose of the same with the following directions to the respondents:-

"...5. In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No.2/Director, School Education, Haryana, to consider and decide the pending legal notice dated 29.01.2024, by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order.

6. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹25,000 to the petitioner."

In compliance of the aforementioned order of the Hon'ble High Court the legal notice of the petitioner dated 29.01.2024 has been examined and it has been found that the petitioner No. 1 namely Mukesh Sharma PGT Hindi has prayed to count regular services rendered by him in a privately managed recognised aided school run by D.A.V. Senior Sec. School, Shahabad Markanda, District Kurukshetra towards qualifying service for pensionary benefits. Whereas, the petitioner No.1 namely Mukesh Sharma was appointed as S.S. Master on an unsanctioned post in the said school and he worked from 17.01.1994 to 07.08.2009 . However, the petitioner had applied for the Post of PGT through proper channel,in Haryana School Teacher Selection Board (HSTSB) Panchkula vide Memo No. 02/2013-HSTSB/2013/CA/45 dated 13.01.2014. Thereafter, the petitioner was appointed on the post of PGT (Hindi) vide order No. 6/4-2013 HRL (4) Hindi dated 10.06.2015 and petitioner had joined duties on 01.07.2015 at Government high School, Gudha District Kurukshetra.

Petitioner No. 2, Sh. Bhim Singh is a TGT and he is under the control of Director Elementary Education Haryana, Panchkula. Therefore speaking order in his respect will be passed by him.

Whereas, Finance Department, Haryana vide its U.O No. 60/202/10/2FD-11/870A dated 31.05.2011 advised that benefit of past services rendered by an employee in a Government Aided establishment before appointment in Government institution may be granted to those who are considered under Special Pension and Contributory provident Fund Rules 2001 for aided schools.

Whereas, rule 5 of Haryana Aided School (Special Pension and Contributory fund), Rules 2001 provides that the service of an employee shall qualify for retiral benefits if service has been rendered at aided sanctioned post subject to other conditions therein.

W

The Government of Haryana framed the Haryana School Education Rules, 2003 for regulating the services of the employees on unsanctioned posts. Rule 162 of the Haryana School Education Rules, 2003 provides that every managing committee of recognized school shall frame the rules and regulations of their employees. Rule 162(1) of the Haryana School Education Rules, 2003 is reproduced as under:-

Every managing committee of recognized school i.e. running under self- finance scheme shall frame the rules and regulations of their employees in relation to:—

- (i) Service conditions of the employees;
- (ii) Recruitment procedure;
- (iii) Salary to the teachers (not less than minimum wage policy of the state);
- (iv) Service Benefits i.e. Contributory Provident Fund,
  Medical, Leave, Increments etc.
- (v) Qualifications of teaching and non-teaching (not less than prescribed under Appendix A to these rule);
- (vi) Code of conduct and penalties;
- (vii) Constitution of disciplinary committee etc.;
- (viii) The school authority shall pay the salary to the staff through Cheque/Bank.

Whereas, the petitioner No.1 namely Muskesh Sharma was appointed by the management on unsanctioned posts in the D.A.V. Senior Sec. School, Shahabad Markanda, District Kurukshetra at their own level. The procedure adopted by Managing Committee for appointment of the private respondent does not pertain to the Department. The Department has no concern with the appointment of the petitioner as the said post was never sanctioned by the Department and no grant-in-aid was issued to the school for these posts. There was

no employer-employee relationship of the department with the petitioner.

Therefore, keeping in view of the facts enunciated above, claim of the petitioner as prayed in legal notice dated 29.01.2024 is not maintainable and the same is hereby rejected being devoid of any merit.

### ORDER No. 13/50-2023 HRME-I (3) Dated, Panchkula, the 19/05/2024

Whereas, the petitioner had filed the CWP No.3537 of 2023 titled as Kavita Vs State of Haryana and others, before the Hon'ble High Court praying therein for the issuance of a writ in the nature of mandamus directing the respondents to regularize the services of late husband of the petitioner w.e.f. the date junior/colleagues to late husband of the petitioner have been regularized i.e. w.e.f. 19.08.2014 & to release all consequential benefits arising out of it including the ex-gratia appointment of the petitioner being L.H. of deceased husband.

The above said CWP came up for hearing on 21.02.2023, and on that day, the Hon'ble High Court was pleased to dispose of the same with direction to respondent No.1 i.e.-Additional Chief Secretary to Government Haryana to decide the representation of the petitioner. The operative part of the said order is reproduced as under:-

"Without going into the merits of the case, the present petition is disposed of with directions to respondent No.1-Additional Chief Secretary, Haryana, to decide the representations moved by the late husband of the petitioner seeking regularization of his services, sympathetically, within a period of 8 weeks from the receipt of the certified copy of this order, by passing a speaking order, in accordance with law.

The respondents-Department shall also take into consideration the fact that, in case, after the demise of the husband of the petitioner, services of the juniors were regularized, the same benefit be also given to the late husband of the petitioner."

In compliance of the above said order of the Hon'ble High Court, the representations dated 16.11.2015 (P-6), 07.09.2018 (P-7) and 25.05.2022 (P-8) moved by the late husband of the petitioner were examined by the department and it has been found that the petitioner's husband Sh. Subhas Chander was engaged as part-time class IV (sweeper) in GGHS Isharwal in District Bhiwani on 05.02.2002 against unsanctioned post who was unfortunately expired on 10.12.2022.

Whereas, as per departmental regularization policy dated 11.11.2003/27.02.2004, the seniority of all the part time employees working in Govt. primary/ Middle/ High/ Sr. Sec. School and field offices like O/o DEOs, BEOs, DPEOs, SDEOs etc. as on 30.06.2003 was prepared at district level and this seniority list of part time Class IV employees made at district level acts as a reference point for sponsoring the names of the senior most employee for regularization of this services against vacant regular sanctioned posts of Class IV and accordingly eligible candidates were regularized by department from time to time on the availability of vacant sanctioned post of Class IV as per the seniority list made at district level, the husband of the petitioner stood at seniority no.976-A

Whereas, para No. 12 of the departmental regularization policy dated 11.11.2003 provides that "the very fact that a part time class IV employee has completed more than six years of continuous service shall not confer a right on such employee for regularization of his/her services if no sanctioned posts are available or if such employee is lower in seniority. Every such employee will be considered for regularization only on his/her turn provided a duly sanctioned class-IV is available."

Whereas, it is relevant to clarify here that in compliance of the order dated 19.07.2019 passed in CWP No. 16086 of 2019 titled as Pushpa Devi & Others vs. State of Haryana & Others, the guidelines were issued by the Directorate vide memo no.13/91-2016 HME-1(4) dated 10.09.2019 to constituted a district level committee, headed by DEO concerned for reexamination of the matters of regularization. Accordingly the case of regularization of part time class IV employees were re-examined and it has been found that juniors to the petitioner's husband were regularized w.e.f 16.09.2019 so the services of the late husband of the petitioner had been regularized w.e.f. 16.09.2019 vide order no.E-IV-24/1703-06 dated 28.03.2024 of District Education Officer, Bhiwani.

As far as, the contention of the petitioner regarding benefit of ex-gratia scheme is concerned, it is relevant to clarify here that the services of the husband of the petitioner were regularized w.e.f. 16.09.2019 vide order no.E-IV-24/170306 dated 28.03.2024 and accordingly only 3 years 2 months 24 days less than 5 years were completed of his regular service till the date of his death i.e. from he was completed his regular service from 16.09.2019 to 10.12.2022.

Rule 4(1) of the Haryana Compassionate appointment policy dated 02.08.2019 provides the conditions enabling the family members

of the deceasedor missing Government employee for consideration under ex-gratia scheme, 02.08.2019 which are as under:

1. The family member shall be eligible for consideration of compassionate appointment under these rules subject to the condition that the deceased or missing Government employee should:-

- 1. Have completed five years' service on regular basis;
- 2. Have not attained the age of fifty-two years or more upto the date of death or missing; and
- Not be suspected to have committed fraud or joined any terrorist organization or gone abroad.

Since, the deceased Government employee does not fulfill the conditions mentioned in the above said policy dated 02.08.2019, therefore the petitioner is not entitled for consideration of compassionate appointment.

Thus, keeping in view of the position explained above, the claim of the petitioner demanded through the present writ petition is partially accepted and the claim of the petitioner in context of compassionate appointment is hereby rejected being devoid of merits.

I order accordingly.

- The benefit of notional pay fixation and seniority are hereby granted w.e.f. 06.05.2016 from the date when their juniors have been promoted and actual financial benefits will be admissible to them from the date when they join duty as **PGT Hindi**.
- If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending subsequently, the said incumbents (s) shall be reverted without issuing any notice.
- 3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
- other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

- 5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
- 6. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
- 7. These promotion orders are based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT** (Hindi) provided those seniors are found eligible for the post.
- 8. In case the degree of a teacher is found not to be from a recognized University having no statutory authority/ jurisdiction in regard to award of such degree, the promotion shall be cancelled forthwith and the teachers so promoted shall be liable for strict disciplinary action.
- 9. The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and, posts have been reserved for them pending determination of their eligibility at a later date.
- 10. Inter se seniority based on the feeder cadre shall be determined in the PGT cadre. In other words, if a senior employee in the C&V cadre is found eligible at a later date and vacancy in respect of his/her is occupied by a junior employee then the Junior employee shall have to be reverted back so that such senior employee may get his/her due promotion.
