Subject: Regarding selection of meritorious girl-students of KGBVs of Haryana, through Portal, for participation in Special National Adventure Programme at National Adventure Institute, Pachmarhi (M.P.) from 07.06.2024 to 18.06.2024 in 3 batches.

On the subject cited above.

It is intimated that the HSSPP, on behalf of the Department of School Education, Haryana, Panchkula, has finalized to send **990 participants** (957 Girlstudents & 33 female escort teachers) from various Kasturba Gandhi Balika Vidyalayas (KGBVs) of Haryana, for participation in Special National Adventure Camps scheduled to be held from 07.06.2024 to 18.06.2024 in 3 batches at National Adventure Institute, Pachmarhi (M.P.).

During this Special National Adventure & Nature Study Programme, the participants will be exposed to various sports & adventure activities like- Trekking, Zip Line, Sky Cycling, Rock Climbing, Valley Crossing, Rappelling, Rifle Shooting, Pistol Shooting, Archery, Obstacle Crossing, Boating, Horse Riding, Night Hike, Introduction of Scouting & Guiding, Nature & Environment Study, Study of Culture & Heritage of the Tribes of Pachmarhi, cultural competitions under Camp Fire etc. **Total 30 participants from each KGBV (29 Girls of VI to XII Classes and 1 Female Escort Teacher)** will be selected to participate in it.

The selection of students as well as escort teachers will be done through a Portal on the Departmental website <u>https://schooleducationharyana.gov.in</u> as per the specific criteria. **This Portal will remain open till 20.05.2024 up to 11:59 Midnight**. The link of Portal is also given below:-

Hence, it is requested that **maximum students from various KGBVs only** may be registered on the Portal. The selection will be done through the Portal itself on merit basis as per the selection criteria. The copy of **selection criteria for students and user manual for handling the portal is enclosed** herewith for detailed information.

The guidelines regarding registering the students and teachers on the Portal are as under:-

- 1. All the Principals/Heads of KGBVs will open the Portal by way of using 'School MIS LOGIN ID' and PASSWORD and upload the entries of students pertaining to their schools on the portal.
- 2. The **PP size photo** of student/teacher will be uploaded on the portal in **jpg format** with **maximum size to 200 KB**.

3. The other **documents**, as required as per the selection criteria, likecertificates of achievements like- DMC, certificate of position/participation in various events/activities etc. will be uploaded on the portal in **pdf format** with **maximum size to 1 MB**.

- 4. The School Head can make any correction/amendment (with regard to Students only) at any time as per their requirement till the portal is open.
- 5. The APCs (YECs & KGBVs) and District Coordinators (Youth & Eco Clubs) will give it a wide publicity and contact the school heads pertaining to their district in order to ensure that **minimum 50 Girls** may be registered for this event from each KGBV.
- 6. The consent of parents must be taken from the parents of the students who are willing to apply for this event, in the enclosed format, before registration.
- 7. The medical fitness certificate will be compulsory for all participants including teachers. The teachers in KGBVs are working on contractual basis and not having MIS IDs, hence, teachers need not to apply on the Portal. The name of one teacher from each KGBV will be finalized by the KGBV Head concerned in consultation with the DPC concerned.
- 8. The hard copies of Parents' Consent and Medical Fitness Certificate w.r.t. the selected candidates, will be produced at the time of reporting in the camp.
- 9. The list of selected students will be shared with the Heads of KGBVs along with the detailed instructions regarding schedule of journey and camps, place of reporting, activities, material to be brought, Do's & Don'ts etc.
