3. He/She will not request to extend the leave from abroad.
4. He/She will not accept any service in Government/Non-Government sector.
5. He/She bears all expenditures himself/herself and the Government will not bear any expenditure for his/her travelling.
6. There shall be no negative impact on the security of the country.
7. He/She will be loyal to the constitution of India and obey all rules and instructions.
8. It has been decided vide order No. 1/3-2018 Admn. (I) dated 11.02.2020, if any employee applies for more than two months permission, their posts will be treated as vacant and they will participate in Transfer drive for their adjustment.
