Whereas PIET Sanskriti School, Sector-25, HUDA, Panipat Managing Committee, Vidyapeeth Education Trust, Panipat was granted recognition upto 8th level vide order no. 17/4-2012 PS (3) dated 28.05.2013 by the Director Elementary Education Haryana, Panchkula under the provisions of Haryana State Right of Children to Free and Compulsory education Rules, 2011.

Whereas a complaint was received against the school from Sh. Ramesh Kumar R/o Aasan Kalan, Panipat wherein, it was alleged that the school has obtained CBSE recognition by submitting wrong documents and that it is not recognized as per the government norms.

Whereas the District Education Officer, Panipat has intimated that the school is recognized up to 8th class and classes are being conducted up to 10th class.

Whereas Rule 3 provides that no school in the state can function, establish or start classes without the prior approval or permission from the competent authority. The Rule 3 of the Haryana School Education Rules, 2003 is reproduced here as under: -

Rule 3 (1): No school in the state can function, establish or start classes without the prior approval or permission of the Director. Every school established by any individual or association of individuals or firm or society or trust or company shall follow the norms specified under these rules, any act or disobedience on the part of the school managing committee contrary to the provisions of these rules shall make its liable:

Whereas, Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution

(2) The recognition/NOC of the school shall lapse if the school,-

- (d) XXXX.
- (e) has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why action may not be taken against the school management under Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.

- Their appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
- 2. They are also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

1. Their appointment is against a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present.

- Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
- 2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month.
