ORDER NO. 13/8-2024 PGT-II (6) DATED, THE PANCHKULA 26/06/2024

Whereas, Smt. Naresh Kumari had filed a CWP No. 2850 of 2024 titled as Naresh Kumari Vs State of Haryana and others for issuance of order or direction especially a writ in the nature of mandamus for directing the respondents to provide APARs (Annual Performance Assessment Report) of the petitioner for session 2016-17 and 2017-18 from respondent No. 5 (Zilaph Kumar) i.e. Principal GSSS Mandholi Khurd to the concerned school i.e. Government Girls Senior Secondary School, Bhiwani and directing the respondent No.5 to get the APARs of both years completed and submitted to the petitioner and to the school where he is posted. It was further prayed to pass an order to punish the Respondent No.5 as per procedure guided by law for abuse of administrative power with mala-fide and bad intention whereby the respondent no.5 illegally kept the APARs of the petitioner for session 2016-17 and 2017-18 and made every effort to impose wrong punishment on the petitioner.

The aforesaid civil writ petition came up for hearing on 09.02.2024, and on that day, the Hon'ble High Court was pleased to dispose of the said petition with the direction to respondent No - 2 to decide the representation of the petitioner. The operative part of the order dated 09.02.2024 is as under:-

"4. In view thereof, the petition is dismissed as withdrawn with liberty to the petitioner to file a representation before respondent No.2 within a period of one week from today. In case any such representation is filed, the same shall be decided by respondent No.2/Director Secondary Education Department, by passing a speaking order in accordance with law, within a

period of three months from the date of receiving the representation”.

Whereas, in pursuance of the above said order of the Hon'ble High Court, the petitioner submitted her representation dated 13.02.2024, which was examined by the department. Through representation, the applicant prayed to direct Mr. Zilaph Kumar to provide APARs (Annual Performance Assessment Report) of the applicant for session 2016-17 and 2017-18 and to punish Mr. Zilaph Kumar as per procedure guided by law for abuse of administrative power with mala-fide and bad intention whereby the respondent no.5 illegally kept the APARs of the petitioner for session 2016-17 and 2017-18. The applicant also stated that Mr. Zilaph Kumar will soon retire from the service on 31.03.2024, and he has badly harassed the applicant during his service tenure and further requested to withhold his retirement benefits.

Whereas the District Education Officer, Bhiwani was directed vide letter No. 13/08-2024 PGT II (6) dated 07.03.2024/15.03.2024 to inspect the matter and submit a report. The District Education Officer, Bhiwani submitted its report vide memo No.E-11-24/2267 dated 04.04.2024, wherein, it has been mentioned that the matter regarding representation submitted by Smt. Naresh Kumari was enquired by the Block Education officer, Siwani on 02.04.2024. It has been further stated that APARs of the applicant for the year 2016-17 and 2017-18 was written by the principal and the same were kept with himself which is illegal as per rules and allegation made by the applicant against Mr. Zilaph Kumar has been found to be true. Apart from this, it is relevant to mentioned here that APARs of the applicant for the year 2016.17 and 2017-18 have been sent by the DEO, Bhiwani and the same are issued to the applicant. Therefore, the claim of the petitioner regarding providing APARs for the year 2016-17 and 2017-18 has been accepted.



Rule 12 (2) (b) of Haryana Civil Service (Pension) Rules, 2016 provides provision regarding departmental proceedings, if not instituted while the Government employees was in service, whether before his retirement, or during his re-employment. Rule 12 (2) (b) clause (ii) of the said Rules is reproduced here as under: -

"12. Right of appointing authority to withhold or withdrew pension.-

(2) (b) The departmental proceedings, if not instituted while the Government employee was in service, whether before his retirement, during his re-employment,-

(i) *****

(ii) shall not be in respect of any event which took place more than four years before such institution.

Whereas, as per rule the claim of the petitioner to punish Mr. Zilaph Kumar as per procedure guided by law is not maintainable because the act of omission and commission was committed by the respondent No.5 i.e. Zilaph Kumar six years before his retirement and the action could have been taken against him till the year 2022. At this stage, it is not possible to take any departmental action against him.

Therefore, keeping in view of the facts enunciated above, the claim of the petitioner with regard to provide APARs (Annual Performance Assessment Report) of the applicant for session 2016-17 and 2017-18 has already been accepted. However, claim regarding punishment and withholding the retrial benefits of respondent no. 5 i.e Zilaph Kumar has no force and the same is hereby rejected.

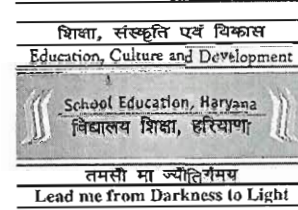
