On the recommendation of the Haryana Public Service Commission, Panchkula against Advt. **Terms and conditions:-**

1. This appointment is only on provisional basis in pursuance of Haryana Govt. instruction No. 52/6/2018-2HR-III dated 05.02.2024



- and the regular appointment letters and place of posting will be issued later on.
2. The concerned candidates are directed to join duties in the O/o Director Secondary Education Haryana, Shiksha Sadan, Sector-5, Panchkula immediately.
  3. The candidate shall have to take an oath of allegiance to the Constitution of India before issuance of regular appointment letter.
  4. The candidate shall not claim seniority on the basis of this order. His/her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
  5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
  6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
  7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
  8. The candidates shall be governed by the Mewat District School Education (Group-B) Service Rules-2012.
  9. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or or one month's salary, in lieu thereof, his/her one month's salary including allowances etc.
  10. No TA/DA will be admissible to the candidate for joining as PGT.
  11. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
  12. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
  13. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-



declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisions of Indian Penal Code (IPC) etc as deemed fit.

14. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/06/2018-2HR-III dated 05.02.2024.
15. Presently exemption to submit Medical Fitness Certificate is granted. However, the same should be submitted before joining in the schools when the regular appointment letter is issued.
