Mr. Harish Kumar Nain, AAG, Haryana accepts notice on behalf of the respondents.

This Court is of the opinion that the matter needs to be looked into at a higher level by the competent authority as to how payments have been disbursed to the petitioners and similarly situated persons, in spite of the fact that the order was rectified on the very next day.

Let, appropriate affidavit be filed as to what action has been taken against the delinquent officers. Status report be filed by the next date of hearing.

List on 08.11.2021.

In view of the apparent fraud with the State exchequer, this Court is of the opinion that it is not a fit case for granting stay."

In compliance of the above said order, a Committee was constituted by the Department on 14.10.2021 to enquire into the matter and the Committee submitted enquiry report on 17.12.2021. As per the Committee report, the delinquent **Sh. Amit Kumar, Clerk O/o BEO Bhiwani** was charge-sheeted U/R 7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 vide order No. 13/136-2021 HRME-I (3) dated 28.04.2022/14.07.2022 wherein the following charges were levelled against him:-

"That the services of 39 Class-IV Part Time employees had been regularized by DEO Bhiwani, w.e.f. the dates mentioned against their names in the orders dated 30.12.2019. However, the services of some of the in-eligible Part Time Class-IV employees had also been regularized inadvertently due to over sight of factual position /facts. Therefore, the said orders were withdrawn on the very next day vide order dated 31.12.2019.




But you prepared the bill of arrear of Sh. Jai Bhagwan, Peon on the basis of photocopy of order dated 30.12.2019 produced by her without verifying the same from the office of DEO Bhiwani. Thus, by doing so you have caused financial loss to the State Exchequer because the payment of Rs. 5,17,245/- was made to her on the basis of bill prepared by you."

The delinquent submitted the reply to the chargesheet on 24.08.2022 and denied the charges levelled against him. Further, vide order No. 13/136-2021 HRME-I (3) dated 13.04.2023, Sh. Sat Parkash, IPS (Retd.) was appointed inquiry officer in the matter. He submitted his inquiry report dated 18.07.2023 whereby the charges levelled against him were found not to be proved. Hearing was granted to him by undersigned on 25.06.2024.

Hence, keeping in view the report of Enquiry Officer and other documents on record and narration of events by the employee during course of hearing, I, hereby decide to drop the chargesheet issued under Rule-7 of Haryana Civil Services (P&A) Rules, 2016 against Sh. Amit Kumar, Clerk O/o BEO Bhiwani.

I order accordingly.
