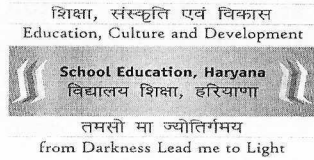

**ORDER**

On the recommendation of the Haryana Public Service Commission, Panchkula against Advt. No. 29/2023 conveyed vide their Memo No. RG-34/2022/4329 dated 27.06.2024, the Governor of Haryana is pleased to appoint the following candidates as Post Graduate Teachers **Mathematics** (HES-II) (Rest of Haryana Cadre) in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 – 1,51,100/- plus usual allowances as admissible from time to time. **Terms and conditions:-**

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The candidate shall have to take an oath of allegiance to the Constitution of India.
3. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.

7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
9. The candidates of Rest of Haryana Cadre shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
10. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
11. No TA/DA will be admissible to the candidate for joining as PGT.
12. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
13. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
14. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisions of Indian Penal Code (IPC) etc as deemed fit.
15. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within two months. This relaxation does not confer any right to a candidate to remain in job, if subsequently

anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/06/2018-2HR-III dated 05.02.2024.

16. The concerned candidate is directed to join duties at place of posting within 15 days and send the joining report (duly signed by DDO) at [dsepgt1@gmail.com](mailto:dsepgt1@gmail.com), failing which this offer of appointment letter will be deemed to have been withdrawn.
17. If the candidate is willing to accept this offer of appointment as PGT HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.

- i. To check the relevant documents of the candidate before allowing his/her to join at the allotted station.
- ii. To take the attestation form and self-declaration form from the candidate before allowing his/her to join duties.
