

The National Awards for Empowerment of Persons with Disabilities were instituted to focus public attention on issues concerning persons with disabilities and to promote their mainstreaming into the society. These awards are conferred on 3rd December every year on the 'International Day of Persons with Disabilities' to outstanding persons with disabilities, individuals and institutions that are working for the empowerment of persons with disabilities.

2. The Guidelines for the National Awards for Empowerment of Persons with Disabilities have been simplified and rationalized, and these are available on the website of the Department (www.depwd.gov.in) as also on the Award Portal (www.awards.gov.in). A brief note indicating the category of awards, specified disabilities is enclosed as an Annexure.

3. An advertisement for inviting applications for the National Awards for the year 2024 is being published in the national/regional dailies soon. The applications/nominations for the award have been invited through online mode only on the password protected centralized portal designed by Ministry of Home Affairs (www.awards.gov.in). The online nomination/application has started from 15th June, 2024 and the last date for the nominations is 31st July, 2024.

4. I shall be grateful if widespread publicity is given to these awards within your Ministry/Department and amongst the autonomous bodies/organizations working therein with a view to encouraging nominations/applications for these awards.
