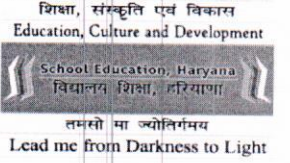

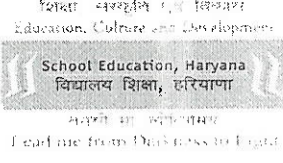

SPEAKING ORDER

No. 13/261-2023 PGT-I (1)

Dated, Panchkula, the 15/11/2023

Whereas, Sh. Javed Hussain had filed a CWP No. 26498 of 2023 titled as Javed Hussain vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein to finalize the seniority list of the TGT and thereafter Lecturers (School Cadre) PGT for the purpose of promotion of petitioner.

The Hon'ble Punjab & Haryana High Court disposed of the said petition on dated 28.11.2023 with following orders:-

".....In view thereof, without going into the merits of the case, the petition is disposed of with a direction to respondent no.2-Director Secondary Education, to consider and decide the pending representation, dated 27.04.2023, by passing a speaking order in accordance with law, within a period of three months from receiving a certified copy of this order.

In case the order is not passed within the stipulated period, the officer concerned shall pay costs of 25,000 to the petitioner."

In compliance of above said order, the representation dated 27.04.2023 of Sh. Javed Hussain, PGT English has been duly examined and it is found that the petitioner has prayed to change his cadre from Rest of Haryana to Mewat Cadre. The petitioner was initially appointed as JBT/PRT on 09.03.1999 in joint cadre prior to the creation of Mewat Cadre and thereafter, he was promoted to the post of TGT Social Studies on 12.12.2010 in Rest of Haryana Cadre. Later on, he was promoted as PGT English vide order No. 15/13-2017 PGT-II (3) dated 24.04.2017 (ROH).

Whereas, in 2012, the department created two separate cadres namely Mewat Cadre and Rest of Haryana Cadre. Further, School Education (Group B) Service Rules, 2012 were also drafted for the employees posted in the Mewat District. Subsequently, a tentative seniority list of PGT (Mewat Cadre) was made on 05.04.2017. Consequently, some of the employees challenged this tentative seniority list by filing a CWP No. 11285 of 2017 titled Ramesh Kumar & Ors. vs. State of Haryana & Ors. The Hon'ble High Court disposed off the Writ Petition on 22.05.2017 with the following directions:-

"Petitioners have questioned the tentative seniority list of Lecturers (Mewat Cadre) as on 05.04.2017. The petitioners are stated to have submitted objections to the same. The concerned respondent has not considered the objections and suggestions and finalized the seniority list. Writ petition is premature. The concerned

respondent is hereby directed to consider petitioners' objections/suggestions with reference to tentative seniority list and finalize the same and communicate to the petitioners at the earliest. With the above observations, petition stands disposed off".

Whereas, in view of the above said order, the Department gave option on 07.11.2017, 14.11.2017 and 20.11.2017 to the all Post Graduate Teachers to opt for either Mewat Cadre or Rest of Haryana Cadre. Thereafter, the Department again on 12.12.2017 and 20.12.2017 gave option to employee posted in Gurugram District to opt for either Mewat or Rest of Haryana Cadre as well as to raise objections regarding the tentative Seniority list if any. Sh. Javed Hussain miserably failed to submit his option despite number of opportunities given to him. Furthermore, he has already been promoted to the post of PGT English in Rest of Haryana Cadre vide order No. No. 15/13-2017 PGT-II (3) and he has accepted the offer of the promotion by joining on the promotional post.

Whereas, in 2017, after receiving the options from the District Education Officer Mewat and other district, on 01.01.2018 the seniority of Mewat Cadre was prepared.

Since, the Department has already prepared and finalized the Seniority list of Trained Graduate Teachers (Mewat Cadre) on dated 16.05.2022 as per the options received through District Elementary Education Officers and disturbing the same will cause the infringement of right of employees in the above said list.

In view of the facts mentioned above, representation of Incumbent and documents on record, the claim of Sh. Javed Hussain is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.
