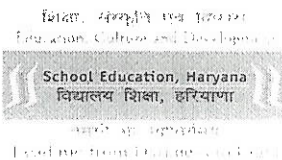

Whereas, Sh. Pushpender Singh has filed the CWP No. 13402 of 2024 titled as Pushpender Singh Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying therein to direct the respondents to offer the appointment letter to the petitioner for the post in question and allotment of a station/school as the similar matter has already been allowed in a bunch of petition by the Hon'ble High Court in CWP No. 7626 of 2015 titled as Gurmail Kaur and others vs. State of Haryana.

The above mentioned writ petition came up for adjudication on 30.05.2024 and the Hon'ble Court disposed of the same vide order dated 30.05.2024. The operative part of the same is as under: -

“...In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No.3/Director of Secondary Education, Haryana, to consider and decide the pending legal notice, dated 26.04.2024, Annexure P-22, by passing a speaking order in accordance with law, within a period of eight weeks from the date of receiving a certified copy of this order.

In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 25,000 to the petitioner.”

In compliance of the above said order dated 30.05.2024 passed by the Hon'ble High Court, the legal notice dated 26.04.2024 has been examined and thereupon, it has been found that the candidature of the petitioner was not considered by the Department on the ground that the petitioner has obtained the requisite qualification from the deemed to be university i.e. Institute of Advanced Studies In Education University, Sardarshahar, Rajasthan.

Whereas, it has been specifically mentioned in Rule No. 2 (h) of the 2012 Rules that only the recognized universities were considered for the purpose of appointment/promotion to the post of PGT. The relevant portion of the Rule is reproduced here as under:-

2 (h) Recognized University

- (i) any university incorporated by Law in India; or
- (ii) any other university which is declared by the Government to be a recognized university for the purpose of these rules;

Whereas Institute of Advanced Studies in Education University, Sardarshahar, Rajasthan is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Govt. and UGC. Whereas this University did not take permission from the State Government and UGC before opening study center to run distance education programme. In absence of the permission of UGC and State Government wherein study centers are located, the degrees obtained from such study centers by the candidates are not legal and such candidates are not eligible for appointment/promotion as PGT in Haryana Govt. Services.

Whereas, similar candidates seeking appointment had earlier filed a CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court allowed the writ petition vide order dated 27.05.2015.

Now the matter is pending in the Hon'ble Supreme Court in SLP No.017134/2021 titled as State of Haryana and others vs. Gurmail Kaur and others. Which is fixed for 22.10.2024 (tentative).

Whereas, similar situated candidates pertaining to appointment have filed CWP No. 22528 of 2021, which was allowed by Hon'ble High Court on 29.08.2022. Thereafter, the department has filed the Latent Patent Appeal No. 98 of 2023 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 29.08.2022 & the matter is now pending for adjudication on 11.09.2024 wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the order dated 02.02.2023 is reproduced here as under:-

".....Granting time to the respondent to file reply to the stay application, this Court in the meanwhile, by way an ad-interim measure, stay operation of the impugned judgment passed by the learned Single Judge."

Whereas, at this stage the issue w.r.t. deemed universities is *sub-judice* before the Hon'ble Apex Court as well as before the Hon'ble High Court and there is an interim order passed by the Hon'ble High Court dated 02.02.2023 as referred *supra*.

Keeping in view of the facts mentioned above & documents on record and orders of Hon'ble Division Bench, the claim raised by Sh. Pushpender Singh in his legal notice dated 26.04.2024 is not tenable at this stage & hereby rejected being devoid of merits.

I order accordingly.



Whereas, JP Jain Senior Secondary School, Sonipat was granted permanent recognition upto 12th level vide order no. 4/5-96 V-1 (3) dated 27.08.1999 by the Director Secondary Education, Haryana, Panchkula.

Vinod Kumar had filed CWP No. 20364 of 2022 titled as Vinod Kumar Vs State of Haryana and others before Hon'ble Punjab and Haryana High Court praying therein a writ in nature of mandamus directing the respondent Department especially respondent No. 2 to consider the petitioner for promotion to the post of PGT Hindi.

The Hon'ble High Court was pleased to dispose of the said petition on dated 08.09.2022 with following orders:-

".....without expressing any opinion on the merits of the case or the claim being made by the petitioner in the legal notice-cum-representation, respondent No.2 is directed to decide the legal notice-cum-representation dated 28.04.2022 (Annexure P.7), by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order."

In compliance of above said order, the legal notice dated 28.04.2022 of the petitioner has been examined. The petitioner is claiming that he is entitled for promotion to the post of PGT Hindi in Rest of Haryana Cadre with effect from the date from which the employees junior to him have been promoted.

Whereas, Sh. Vinod Kumar was appointed as Hindi Teacher since 1997 in District Mewat in joint cadre prior to the creation of Mewat cadre.

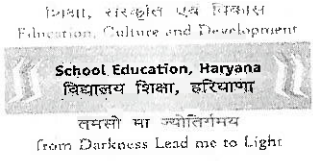

Whereas, Sh. Vinod Kumar had filed CWP No. 20364 of 2022 titled as Vinod Kumar Vs State of Haryana and others before Hon'ble Punjab and Haryana High Court praying therein a writ in nature of mandamus directing the respondent Department especially respondent No. 2 to consider the petitioner for promotion to the post of PGT Hindi.

The Hon'ble High Court was pleased to dispose of the said petition on dated 08.09.2022 with following orders:-

".....without expressing any opinion on the merits of the case or the claim being made by the petitioner in the legal notice-cum-representation, respondent No.2 is directed to decide the legal notice-cum-representation dated 28.04.2022 (Annexure P.7), by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order."

In compliance of above said order, the legal notice dated 28.04.2022 of the petitioner has been examined. The petitioner is claiming that he is entitled for promotion to the post of PGT Hindi in Rest of Haryana Cadre with effect from the date from which the employees junior to him have been promoted.

Whereas, Sh. Vinod Kumar was appointed as Hindi Teacher since 1997 in District Mewat in joint cadre prior to the creation of Mewat cadre.


Whereas, in 2012, the department created two separate cadre namely Mewat cadre and Rest of Haryana Cadre. Further, Haryana School Education (Group-B) Service Rules (Mewat Cadre), 2012 were also notified for the employees posted under Mewat cadre. The case of the petitioner was received vide No. 1/22/10526-27 dated 26.12.2022 from the District Education Officer, Nuh for promotion in rest of Haryana Cadre. Thereafter, Sh. Vinod Kumar was directed to submit online choice for allotment of station with respect to the promotion. However, the petitioner declined to submit online option stating that he belongs to Mewat Cadre. The petitioner has also submitted an affidavit in this regard. Whereas, vide memo No. 13/137-2022 PGT-1(3) dated 03.06.2024, DEO, Nuh was requested to enquire and submit her report. In this regard, the District Education Officer, Nuh submitted her report vide memo No.E-1/2024/777 dated 14.06.2024 and stated that the petitioner is under Mewat Cadre after receiving his option and he has also been including in seniority for Mewat Cadre.

As per record, Sh. Vinod Kumar is working in Mewat Cadre since beginning of his service on dated 30.09.1997 and also opted for Mewat Cadre.



Hence, the claim of Sh. Vinod Kumar for promotion as PGT Hindi in rest of Haryana Cadre is not tenable & hereby rejected being devoid of merits.


