Sir/Madam,

I have been directed to invite your attention to the subject cited above and to state that it has been brought to notice by the departmental coaches that many serving State/Central Govt. employees who have already taken the benefit of being selected under sports quota take part in Khel Mahakumbh. Such individuals who are excellent sportsperson normally become members of team in team sports which gets gold or silver with intention to benefit other members of the teams to get the sports gradation certificate. This leads to discrimination against new upcoming sportspersons and their chances of getting of sports gradation certificates are limited.

The matter was duly considered and it is decided that in future no serving State/Central Govt./PSUs/Board/Corporation employee who has taken appointment on the basis of his/her sports achievement shall be eligible to play/participate in any sport/event under the Khel Mahakumbh in Haryana. To implement this, at the time of registration an undertaking must be taken from all participating sportspersons. In case any sportsperson is later found to have submitted false undertaking then criminal/departmental action may be taken/recommended against him/her. These instructions shall be applicable from Khel Mahakumbh 2024 onwards.
