Whereas, Sh. Vinod Kumar had filed CWP No. 20364 of 2022 titled as Vinod Kumar Vs State of Haryana and others before Hon'ble Punjab and Haryana High Court praying therein a writ in nature of mandamus directing the respondent Department especially respondent No. 2 to consider the petitioner for promotion to the post of PGT Hindi.

The Hon'ble High Court was pleased to dispose of the said petition on dated 08.09.2022 with following orders:-

“.....without expressing any opinion on the merits of the case or the claim being made by the petitioner in the legal notice-cum-representation, respondent No.2 is directed to decide the legal notice-cum-representation dated 28.04.2022 (Annexure P.7), by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order.”

In compliance of above said order, the legal notice dated 28.04.2022 of the petitioner has been examined. The petitioner is claiming that he is entitled for promotion to the post of PGT Hindi in Rest of Haryana Cadre with effect from the date from which the employees junior to him have been promoted.

Whereas, Sh. Vinod Kumar was appointed as Hindi Teacher since 1997 in District Mewat in joint cadre prior to the creation of Mewat cadre.


Whereas, in 2012, the department created two separate cadre namely Mewat cadre and Rest of Haryana Cadre. Further, Haryana School Education (Group-B) Service Rules (Mewat Cadre), 2012 were also notified for the employees posted under Mewat cadre. The case of the petitioner was received vide No. 1/22/10526-27 dated 26.12.2022 from the District Education Officer, Nuh for promotion in rest of Haryana Cadre. Thereafter, Sh. Vinod Kumar was directed to submit online choice for allotment of station with respect to the promotion. However, the petitioner declined to submit online option stating that he belongs to Mewat Cadre. The petitioner has also submitted an affidavit in this regard. Whereas, vide memo No. 13/137-2022 PGT-1(3) dated 03.06.2024, DEO, Nuh was requested to enquire and submit her report. In this regard, the District Education Officer, Nuh submitted her report vide memo No.E-1/2024/777 dated 14.06.2024 and stated that the petitioner is under Mewat Cadre after receiving his option and he has also been including in seniority for Mewat Cadre.

As per record, Sh. Vinod Kumar is working in Mewat Cadre since beginning of his service on dated 30.09.1997 and also opted for Mewat Cadre.



Hence, the claim of Sh. Vinod Kumar for promotion as PGT Hindi in rest of Haryana Cadre is not tenable & hereby rejected being devoid of merits.

- iii. The compliance of the condition No. 16 should be complied within the stipulated period.
- iv. To send the joining report of PGTs to HQ.
