Whereas, Sh. Gurdeep Kumar has filed present Civil Writ Petition No. 15822 of 2021 titled as Gurdeep Kumar vs. State of Haryana & another before the Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to fix the seniority of the petitioner over and above the persons junior to him on the post of PGT who were appointed after the petitioner and some of them are younger in age though they were regularized in the services on the same date i.e. 01.10.2003 on which the petitioner was regularized.

The Hon'ble Punjab and Haryana High Court disposed of said petition on dated 18.08.2021 with the following orders:-

“.....Accordingly, without commenting on the merits of the case or the entitlement of the petitioner, the present petition is disposed of with the direction to respondent No.2 to take a decision on the legal notice dated 03.05.2021 (Annexure P-15) within a period of 3 months from the receipt of the certified copy of this order. In case the petitioner is held entitled for the relief sought, the effect of necessary benefits be implemented, thereafter. In case there is any legal impediment and the relief is to be denied, speaking order be passed and communicated to the petitioner.”

Whereas, in compliance of the abovesaid order, the legal notice dated 03.05.2021 of Sh. Gurdeep Kumar, PGT Chemistry has been examined and it is found that the he was initially appointed as PGT/Lecturer (Chemistry) vide order No. 6/15-94-E-IV(4) dated 19.08.1994 on Contractual/Ad hoc basis and there after services of the petitioner was regularized as per the instructions letter No. 6/9/03-IGS-I dated 01.10.2003.

Whereas, Government of Haryana issued instructions vide dated 01.10.2003 for regularization of service of ad-hoc employees subject to fulfillment of certain conditions. The petitioner was regularized as per these instructions and clause-4 of these instructions provided for the fixation of seniority of employee so regularized. This clause-4 is reproduced as under:-

“The seniority of ad-hoc/contract or daily wages employees so regularized vis a vis the Group-C and Group-D employees shall be determined



with effect from 1st October, 2003. The inter-se-seniority of such ad-hoc/contract or daily-wages Group-C and Group-D employees shall be determined in accordance with the date (s) of their joining the post on ad-hoc/contract or daily wage basis. If the date of joining the post on ad-hoc/contract or daily wage basis by such ad-hoc/contract or daily wage employee is the same, then an older employee shall rank senior to an employee younger in age. If the date of appointment of the direct recruit and the date of regularization of ad-hoc/contract or daily wage employee is the same, the direct recruit shall be senior."

However, the seniority was inadvertently fixed with respect to the age of the employees. As of now, the seniority of the petitioner and other similar situated employees has been re-fixed tentatively as per Rules/Instructions and policy.

In regard to the counting of ad-hoc services for the benefits of ACP, the Finance Department vide memo No. 6/83/2008-4 PR(FD) dated 17.12.2012 has intimated the departments of the Government of Haryana regarding the claim of Hon'ble Apex Court in SLP No. 29874 of 2009 that the Supreme Court considered the various previous judgement on the issue and the contention raised by party while disposing of SLP No. 29874 of 2009. The operative part of judgement is reproduced as under:-

"None of the aforesaid judgement can be read as laying down a proposition of law that a person who is appointed on purely ad-hoc basis for a fix period by an authority other than the one who is competent to make regular appointment to the service and such appointment made by the specify recruiting agency is entitled to have his ad-hoc service counted for the purpose of fixation of seniority. Therefore, the respondents, who are appointed as Masters in different subjects, Physical Training Instructor and Hindi Teacher on purely ad-hoc basis without following the procedure prescribed under the 1955 rules are not entitled to have their seniority fixed on the basis of total length of service. As a corollary to this, who hold that the direction given by the high court for re-fixation of the respondents seniority by counting that ad-hoc service cannot be approved."

In view of this the claim is not tenable being devoid of merits.

It is ordered accordingly.
