Whereas, Sh. Vikash Kumar and others had filed CWP No. 1177 of 2024 titled as Vikash Kumar and others vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to quash the impugned result dated 05.01.2024 and further, to direct the respondent commission to consider the candidature of present petitioners for the post of PGT Physical Education and also direct the respondents to covert the vacant post under EWS category to General Category.

The Hon'ble High Court was pleased to dispose of the said civil writ petition vide order dated 22.03.2024 with the following orders/directions:-

".....Accordingly, the petition stands disposed of by directing respondents no.2 and 3 to pass appropriate order to fill-up the vacant posts of PGT Physical Education of EWS category (Rest of Haryana cadre), which remained vacant on account of non-availability of candidates under the category, from the general/unreserved category candidates, in terms of instructions dated 25.02.2019, as well as stipulation in the advertisement to that effect, within a period of four weeks from receiving a certified copy of this order."

In compliance of above said order, the case of Sh. Vikash Kumar and others was duly examined. After examination, it has been found that he had applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') – Physical Education against the advertisement no. 31/2023.

Whereas, the Directorate of School Education Department had sent a requisition to the Haryana Public Service Commission (henereinafter called HPSC) for selection and recommendation of the names of eligible candidates for the post of PGT Physical Education. Accordingly, HPSC advertised the said posts vide Advertisement No. 31/2023 dated 24.06.2023. The whole selection process i.e. from issuing advertisement to the declaration of final result is carried out by HPSC. But, HPSC has not recommended the name of the petitioner in the recommendation list being an ineligible candidate in pursuance to the advertisement No. 31/2023.

As per Para 3 (3.3) of the instructions No. 22/12/2019-IGS-III, dated 25.02.2019 and clarification dated 26.06.2024, unfilled EWS category posts can not be filled up from unreserved category, however, if HPSC has prepared waiting list and names of petitioners has been recommended by them then unfilled EWS category posts can be filled up from the unreserved category. Till

ju

date, no recommendation has been received from the recruiting agency i.e. HPSC, despite the fact that clarification dated 26.06.2024 has been sent to them on 09.07.2024.

Keeping in view of the facts mentioned above & documents on record, the claim raised by Sh. Vikash Kumar and others is not tenable and the same is hereby rejected being devoid of merits.



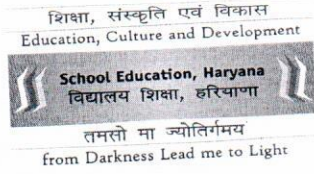

7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self-attested copies. 16. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/08/2022-3GS-III dated 23.06.2022.


